NOTICE REGARDING FEES PAYABLE TO THE COUNCIL IN TERMS OF THE REGULATIONS RELATING TO THE PARTICULARS TO BE FURNISHED TO THE COUNCIL FOR KEEPING OF THE REGISTER FOR NURSING PRACTITIONERS, THE MANNER OF EFFECTING ALTERATIONS TO THE REGISTER, AND CERTIFICATES THAT MAY BE ISSUED BY THE COUNCIL

DEFINITION

1. In this notice, "**the regulations**" means the Regulations Relating to the Particulars to be Furnished to the Council for Keeping of the Register for Nursing Practitioners, the Manner of Effecting Alterations to the Register, and Certificates that may be Issued by the Council published by Government Notice No. R. 195 of 19 February 2008.

ANNUAL FEES

2. The amounts of the annual fee referred to in 8 (1) (a), 9 (2) and 11 (1) of the regulations have been determined by the Council as shown in the table below.
3. These amounts apply to annual fees in respect of the calendar year 1 January 2009 to 31 December 2009, which are due on 31 December 2008, and which must be received by Council by 31 March 2009 (final date for payment).
4. These annual fee amounts will not apply to annual fees paid before the date of publication of this notice in the *Gazette*.
5. These annual fee amounts will apply to all subsequent years until such time that the fees are amended by a notice in the *Gazette*.
