RETAIL PRICE FOR ILLUMINATING PARAFFIN**

- I. Ms. Buyelwa P. Sonjica, Minister of Minerals and Energy, under section 2(1)(c) of the Petroleum Products Act, 1977 (Act No. 120 of 1977), determine that a maximum retail price for illuminating paraffin (excluding the price of any form of packaging) will become effective on the first Wednesday of each month.
2. The maximum retail price for illuminating paraffin, excluding the price of any form of packaging, for the period 1 October 2008 to 4 November 2008 will be 975.0 c/l.
3. **Commencement**
These regulations shall come into operation at **00:01 on 1 October 2008.**

AMENDMENT OF THE REGULATIONS IN RESPECT OF PETROLEUM PRODUCTS

The Minister of Minerals and Energy has, under section 2 (1) (c) of the Petroleum Products Act, 1977 (Act No. 120 of 1977), made the regulations set out in the Schedule.

SCHEDULE

Definitions
