## NOTICE 1415 OF 2008

### AMENDMENT NOTICE IN TERMS OF THE RESTITUTION OF LAND RIGHTS ACT, 1994 (ACT NO. 22 OF 1994), AS AMENDED

Notice is hereby given in terms of section 11A (4) read with section 11A (2) of the Restitution of Land Rights Act, Act No. 22 of 1994, as amended, that with effect from the date of this notice, General Notice No. 773 of 2002 contained in Government Gazette No. 23428 dated 24 May 2002 ("the original notice") is amended by –
