NOTICE OF PUBLIC HEARINGS: SPORT BROADCASTING RIGHTS REGULATIONS

The Independent Communications Authority of South Africa ("ICASA") hereby, in accordance with section 4(6) of the Electronic Communications Act ("ECA") No.36 of 2005, gives notice to convene oral hearings on the Draft Regulations in respect of digital broadcasting framework ("Draft Regulations").

ICASA published the Discussion Document, on 03 October 2008, General Notice 1238, and Government Gazette Number 31483. The Authority invited interested parties, stakeholders, and the public to respond to the issues raised in the Sport Broadcasting Rights Discussion Document. The closing date for the receipt of written representations was extended to 21 November 2008. The Authority received Twelve (12) submissions. Seven (7) of these have indicated their wish to make oral presentations.

Public hearings will be convened on the 22 and 23 January 2008.
