**NINTH AMENDMENT OF THE REGULATIONS MADE UNDER THE

The Minister of Home Affairs has under section 22(4) of the Identification Act, 1997 (Act No. 68 of 1997) and with the concurrence of the Minister of Finance, made the regulations in the Schedule.

**SCHEDULE**

**Definition**

1. In this Schedule "the Regulations" means the Regulations made under section 22(4) of the Identification Act, 1997 (Act No. 68 of 1997), published under Government Notice No. R. 978 of 31 July 1998, as amended by Government Notice Nos. R. 1014 of 7 August 1998, R. 275 of 1 April 2000, R. 329 of 3 April 2001, R. 1213 of 19 August 2003, R. 432 of 31 March 2004, R. 605 of 14 May 2004, R. 701 of 11 June 2004, R. 321 of 1 April 2005 and R. 474 of 19 May 2006.

**Substitution of regulation 15 of the Regulations**

2. The following regulation is hereby substituted for regulation 15 of the Regulations:

**"Fees**

15. The following fees are payable in the respective cases:

- (a) Identity document: Re-issuing: R20-00: Provided that the re-issuing of an identity document is free of charge in those cases where an identity document was issued and with the forename repeated as a surname in the document, if the Department did not insist on an application for insertion of the surname at the time of the initial application, and when a new identity document is issued to a former TBVC citizen to replace his or her old South African identity document indicating him or her as a non-South African citizen.
- (b) Issuing of temporary identity certificate: R20-00.
- (c) Furnishing of information from the population register on magnetic tape or similar format in accordance with the provisions of section 21 of the Act: R320-00 for every 5000 persons or portion thereof.
- (d) Frame of four black and white photos taken for an identity document by the Department: R35-00."

**Short title and commencement**

3. These Regulations shall be called the Ninth Amendment of the Regulations made under the Identification Act, 1997 and will come into operation on 1 April 2009.

**5B. (1)** The marriage officer who solemnizes a marriage shall, after the register referred to in section 29A(1) has been signed, issue to the parties, free of charge, a marriage certificate containing substantially the information prescribed on form BI-27, in respect of the marriage.

(2) The Director-General may upon application issue—

- (a) an abridged marriage certificate, containing substantially the information prescribed on form BI-41;
- (b) a full marriage certificate, containing substantially the information prescribed on form BI-36; or
- (c) a letter of confirmation of an applicant’s marital status based on the particulars contained in a marriage register which is preserved by him or her under the Act or any other law, or of which the particulars are included in the population register mentioned in the Identification Act, 1997 (Act No. 68 of 1997), on receipt of—
  - (i) an amount of R15-00 in respect of a handwritten abridged or computerized abridged marriage certificate: Provided that no fees shall be payable for the issuing of the certificate at the time of the registration of the marriage;
  - (ii) an amount of R70-00 in respect of an unabridged marriage certificate or a reproduction of the relevant register or a reproduction of any supporting documentation which is coupled to the register concerned, or the verification of information contained in a marriage register: Provided that where the reproduction or verification is required for official purposes by a Government institution, it shall be free of charge; or

(iii) an amount of R50-00 in respect of a letter of confirmation of an applicant's marital status.”.

**Short title and commencement**

3. These Regulations shall be called the Twelfth Amendment of the Regulations made under the Marriage Act, 1961 and will come into operation on 1 April 2009.

### **Substitution of regulation 16 of the Regulations**

2. The following regulation is hereby substituted for regulation 16 of the Regulations:

#### **"Fees**

16. (1) Subject to subregulations (2) and (3), the fees payable in respect of a South African passport or travel document issued under the Act shall be as follows:

- (a) South African passport: 32 and 64 pages: R190-00 and R380-00 respectively: Provided that the fee payable for a new format South African passport (32 pages) that runs out of blank visa pages before the expiry date thereof shall be R145-00;
- (b) child passport: R145-00;
- (c) document for travel purposes: R145-00;
- (d) emergency passport: R70-00; and
- (e) temporary passport: R90-00.

(2) No fees shall be payable in respect of an official passport, a crew member certificate, an emergency passport or a temporary passport issued to a person referred to in regulation 2(3) or for the renewal of a passport referred to in regulation 17(3).

(3) The fees payable in respect of the replacement of a lost, stolen or damaged South African passport, child passport, document for travel purposes or temporary passport referred to in subregulation (1) and a passport referred to in regulation 17(3), shall be double the fee mentioned in that subregulation: Provided that in instances where the documents referred to was lost, stolen or damaged through no negligence on the part of the holder, only the fee mentioned in subregulation (1) shall be payable."

### **Short title and commencement**

3. These Regulations shall be called the Fourteenth Amendment of the Regulations made under the South African Passports and Travel Documents Act, 1994 and will come into operation on 1 April 2009.
