PRIVATE SECURITY INDUSTRY REGULATION ACT, 2001
(ACT NO. 56 OF 2001): EXEMPTION IN TERMS OF
SECTIONS 1(2) AND 20(5) OF THE ACT

By virtue of the power vested in the Minister for Safety and Security by sections 1(2) and 20(5) of the Private Security Industry Regulation Act, 2001 (Act No. 56 of 2001), I, Emmanuel Nkosinathi Mthethwa, hereby determine that Dianne Barbra Appelcryn (ID No. 710917 0294 088), is exempted from the provisions of section 20(2)(a) and (b) of the Private Security Industry Regulation Act, 2001 (Act No. 56 of 2001), for a period of five years from date hereof, and may be registered as a member of Appelcryn and Associates CC on condition that -

- She may not directly or indirectly participate or influence the decisions relating to the day-to-day security services provided by Appelcryn and Associates CC;
- She may not function as a security service provider ; and
- She must remain in the employment of Appelcryn and Associates CC.
