No. 7 van 2009: Wet op Aflossing van Oorgeërfde Wes-Kaapse Skuld, 2009.

ACT

To authorise the discharge of certain debts of the former Cape Provincial Administration and the former House of Representatives, which have devolved upon the Western Cape Province in terms of the Constitution of the Republic of South Africa, 1993, and are still outstanding; to make arrangements for the settling of accounts in relation to the debts; and to provide for matters incidental thereto.

BE IT ENACTED by the Parliament of the Republic of South Africa, as follows:—

Definitions

1. In this Act, except if inconsistent with the context, “**inherited debt**” means the liabilities incurred on behalf of the former Cape Provincial Administration and the former House of Representatives, which— 5
- (a) in terms of section 239(3) of the Constitution of the Republic of South Africa, 1993 (Act No. 200 of 1993), or by virtue of any allocation made in terms of that section, devolved upon the Western Cape Province;
 - (b) is still outstanding; and 10
 - (c) is represented by the amounts as specified in column 2 of Schedule 1 to this Act.

Authorisation of inherited debt

2. (1) The unauthorised expenditure of the former Cape Provincial Administration of R 799 366 196.11, which is specified in column 2 of Schedule 1, is hereby authorised. 15
- (2) The unauthorised expenditure of the former House of Representatives of R 112 724 302.23, which is specified in column 2 of Schedule 1, is hereby authorised.
- (3) The amounts referred to in subsections (1) and (2) are direct charges against the National Revenue Fund.

WET

Om die aflossing van sekere skulde van die voormalige Kaapse Provinsiale Administrasie en die voormalige Huis van Verteenwoordigers, wat ingevolge die Grondwet van die Republiek van Suid-Afrika, 1993, na die Wes-Kaapse Provinsie afgewentel het en steeds uitstaande is, te magtig; om reëlings te tref vir die vereffening van rekeninge met betrekking tot die skulde; en om vir aangeleenthede wat daarmee verband hou, voorsiening te maak.

DAAR WORD BEPAAL deur die Parlement van die Republiek van Suid-Afrika, soos volg:—

Woordomskrywing

1. In hierdie Wet, tensy dit nie met die konteks vereenselwig is nie, beteken “oorerfde skuld” die verpligtinge wat namens die voormalige Kaapse Provinsiale Administrasie en die voormalige Huis van Verteenwoordigers aangegaan is, wat—
- (a) ingevolge artikel 239(3) van die Grondwet van die Republiek van Suid-Afrika, 1993 (Wet No. 200 van 1993), of ooreenkomstig enige ander toewysing wat ingevolge daardie artikel gemaak is, oorgegaan het op die Wes-Kaapse Provinsie;
 - (b) steeds uitstaande is; en
 - (c) verteenwoordig word deur die bedrae in kolom 2 van Bylae 1 tot hierdie Wet uitcengesit.

Magtiging van oorerfde skuld

2. (1) Die ongemagtigde uitgawes van die voormalige Kaapse Provinsiale Administrasie ten bedrae van R799 366 196.11, wat in kolom 2 van Bylae 1 uiteengesit is, word hierby gemagtig.
- (2) Die ongemagtigde uitgawes van die voormalige Huis van Verteenwoordigers ten bedrae van R112 724 302.23, wat in kolom 2 van Bylae 1 uiteengesit is, word hierby gemagtig.
- (3) Die bedrae waarna verwys word in subartikels (1) en (2), is 'n regstreekse las teen die Nasionale Inkomstefonds.

Amendment of section 3 of Act 35 of 2000

3. Section 3 of the Finance Act, 2000, is hereby amended by the substitution for the words preceding paragraph (a) of the following words:

“The unauthorized expenditure of [~~R4 139 465 912,82~~] R3 959 123 269,76 referred to in Schedule 3 which—”.

Amendment of Schedule 3 to Act 35 of 2000

4. Schedule 3 to the Finance Act, 2000, is hereby amended by—

- (a) the deletion of the entries and amounts set out in Schedule 2 to this Act; and
- (b) the substitution of the total indicated at the bottom of the first column of Schedule 3, as follows:

“~~[R4 139 165 912.82]~~ R3 959 123 269.76.”.
