**PUBLICATION OF COMPANY AND CLOSE CORPORATION NOTICES IN THE  
GOVERNMENT GAZETTE AND ON THE CIPRO WEBSITE: CORPORATE LAWS  
AMENDMENT ACT, 2006**

Please note that due to the amendment of the Companies and Close Corporations Acts as well as the Companies and Close Corporations' Administrative Regulations, CIPRO will no longer publish Companies and Close Corporations notices in respect of registrations, deregistration, amendments, company name change, restorations, liquidations and conversions in the Government Gazette. These notices will in future be published on the CIPRO website.

The cut-off date for changing to the new system of publication of notices on the CIPRO website was 12 March 2009.

All notices requiring to be published up to, and including 12 March 2009, will be included in the next Government Gazette to be published in the physical Government Gazette.

From 13 March 2009 onwards, all notices will be published on the CIPRO website and will remain available on the website for an indefinite period.
