- ii. On 27 July 2007, the RAF published a further notice in the Government Gazette (Notice Number 921 of 2007) and in the print media, containing a detailed implementation plan for the direct payment system and further inviting comments by the public on the proposal.
- iii. Comments were received and considered and a further notice was published in the media on 21 July 2008, informing the public that the direct payment system would be introduced with effect from 1 August 2008.

REASONS FOR WITHDRAWAL

- a) The Law Society of South Africa, the South African Association of Personal Injury Lawyers and LN Mbele obtained an interdict in the Western Cape High Court, Cape Town, against the RAF implementing a system to pay claimants directly, pending a review of the decision to implement such a system.
- b) The RAF has been advised by its legal representatives that the notice published on 21 July 2008 and the process leading thereto may contain flaws.
- c) As a result of this advice, the RAF has decided to unilaterally withdraw the notice of 21 July 2008.
