#### **DEPARTMENT OF TRADE AND INDUSTRY MERCHANDISE MARKS ACT, 1941 (ACT 17 OF 1941)**

#### **NOTICE ON THE DESIGNATION OF THE BRITISH AND IRISH LIONS TOUR AS A "PROTECTED EVENT" IN TERMS OF SECTION 15A OF THE MERCHANDISE MARKS ACT, 1941**

I, Rob Davies, Minister of Trade and Industry, hereby designate the British and Irish Lions Tour in terms of Section 15A of the Merchandise Marks Act, 1941 as a "protected event" with effect from the date of publication of this Notice.

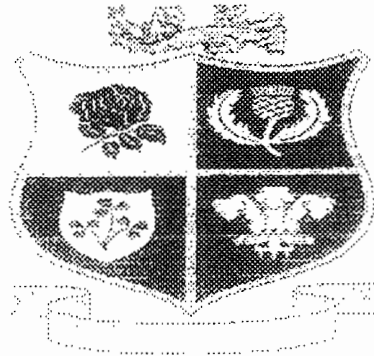
The application for designation was published on the 9<sup>th</sup> of March 2009, Notice 290 of 2009 in Gazette No 31996. The date of termination of the protected event status is one (1) calendar month after the event has come to the end.

OF THE BRITISH AND IRISH LIONS**

I, Rob Davies, Minister of Trade and Industry in pursuance of the requirements of section 13 of the Merchandise Marks Act (17 of 1941) hereby publish a Final Notice in terms of section 15(1)(b) of the said Act, on the use of the words and emblems as depicted below, in connection with any trade, business, profession, or occupation or in connection with any trade mark, mark or trade description applied to goods in so far as it is limited to the sport of rugby.
