1. The Independent Communications Authority of South Africa ("the Authority") hereby gives notice, that it has received a notification of a sale and transfer of shares in terms of a sale of shares agreement ("transaction") between Telkom SA Limited ("Telkom") and Shenzhen Media South Africa (Pty) Ltd ("Shenzhen").
2. The Authority hereby publishes this notice in the public interest and to allow any interested person to make comments in respect of the transaction.

Telkom Media (Pty) Ltd shall be entitled to respond in writing to written comments made by interested persons, and such written response must be lodged with the Authority within twenty one (21) days of the date of publication of this notice in the Government Gazette. Telkom Media (Pty) Ltd must, at the time of lodging such written response, furnish proof to the Authority's satisfaction that it has delivered a copy of such response by hand, or has sent a copy of such response by registered mail or by facsimile to the relevant person having made such written comments.
