## APPLICATION FOR THE AMENDMENT OF AN INDIVIDUAL COMMERCIAL SOUND BROADCASTING SERVICE LICENCE: KFM (PTY) LTD

1. The Independent Communications Authority of South Africa ("the Authority") hereby gives notice, in terms of the provisions of section 10 (2) of the Electronic Communications Act, No 36 of 2005, that it has received an application from KFM (Pty) Ltd ("KFM") for amendment of its Individual Commercial Sound Broadcasting Service Licence in terms of section 10(1).
2. The amendment application seeks approval by the Authority of a sale of shares and claims agreement between Broadcape Investments (Pty) Ltd and New Africa Media Holdings (Pty) Ltd ("NAM") and an offer by NAM to purchase a 5\% stake in KFM held by the Employee Share Trust.
3. The application, relevant schedule and any representations received pursuant thereto would be made available and be open for inspection by interested parties in the Authority's library during the Authority's normal office hours.
4. Interested parties are invited to lodge written representations in relation to the application within twenty one (21) days of the date of publication of this notice which will expire on 15 September 2009.
