PROMOTION OF EQUALITY AND PREVENTION OF UNFAIR DISCRIMINATION ACT 4 OF 2000: DESIGNATION OF MAGISTRATES' COURTS AS EQUALITY COURTS; DEFINING THE AREA OF JURISDICTION OF EACH EQUALITY COURT; AND APPOINTMENT OF PLACES WITHIN THE AREA OF JURISDICTION OF EACH EQUALITY COURT FOR THE HOLDING OF EQUALITY COURT SITTINGS.

I, Jeffrey Thamsanqa Radebe, Minister of Justice and Constitutional Development, under section 16(1) of the Promotion of Equality and Prevention of Unfair Discrimination Act, 2000 (Act No. 4 of 2000), as amended, and after consultation with the heads of the administrative regions as defined in section 1 of the Magistrates' Courts Act, 1944 (Act No. 32 of 1944), hereby –

- (a) withdraw Government Notices No. 25091 of 13 June 2003 and No. 26178 of 26 March 2004;
- (b) designate all Magistrate's Courts mentioned in Column A of the Schedule as equality courts;
- (c) define, in Column B of the Schedule, the area of jurisdiction of each equality court mentioned in Column A of the Schedule; and
- (d) appoint the places mentioned in Column C of the Schedule as places of sittings of the equality courts mentioned in Column A.


