AMENDMENT TO POLICY AND REGULATIONS PERTAINING TO THE NATIONAL SENIOR CERTIFICATE

I, Angelina Matsie Motshekga, Minister of Basic Education, with the concurrence of the Council of Education Ministers and in terms of Sections 3(4)(I) and 7 of the National Education Policy Act, 1996 (Act No. 27 of 1996) and together with section 6(A) of the South African Schools Act, 1996 (Act. No. 84 of 1996), hereby approve the amendment to national education policy as stipulated in the following policy documents as set out in Schedules 1 and 2.

- (a) National Policy on the Conduct, Administration and Management of the National Senior Certificate, a Qualification at Level 4 on the National Qualifications Framework (NQF) as promulgated in Government Gazette, No.30048 as Government Notice, No. 564 on 6 July 2007.
- (b) National Senior Certificate: A Qualification at Level 4 on the National Qualifications Framework (NQF), promulgated in Government Gazette No. 27819 as Government Notice, No 744 of 20 July 2005.

The relevant policy changes are set out in the Schedule. Deletions are in square brackets [] and in bold, while insertions are underlined.

SCHEDULE 1

National Policy on the Conduct, Administration and Management of the National Senior Certificate, a Qualification at Level 4 on the National Qualifications Framework (NQF), promulgated in Government Gazette No. 30048 as Government Notice, No 564 of 6 July 2007 is hereby amended by the following:

Amendment of paragraph 18

- 1. Paragraph 18 of the Policy is hereby amended by-
 - (a) the substitution of the introduction of paragraph 18 for the following paragraph-

"A supplementary examination will be granted under the following conditions to a full-time, repeat and part-time candidate:"

(b) the substitution of subparagraph (1) of paragraph 18 for the following subparagraph-

"(1) If a candidate has not met the minimum promotion and certification requirements [in the final external examination, as contemplated in paragraphs 11 and 12, of the policy document, *The National Senior Certificate: A qualification at Level 4 on the National Qualifications Framework (NQF)*], but requires two subjects to obtain a National Senior Certificate, he or she may:

(a) R[r]egister for a maximum of two subjects for the supplementary examination in the following year. <u>This option</u> may only be exercised once by a part-time candidate, namely <u>after completion of the National Senior Certificate, that is, his</u> <u>or her final end-of-year examination.</u>

- (b) Register, subject to subparagraph (c), for [These] two subjects that [the candidate] he or she sat for in the previous end-ofyear examination.
- (c) Register for Life Orientation, which is internally assessed, as one of the two subjects to be registered for the supplementary examination in subregulation (a). The re-assessment of Life Orientation must be completed within the period in which the supplementary examination is conducted."

"2 Candidates that repeat one or more subjects will be allowed to combine their subjects based on the current National Senior Certificate requirements to obtain a National Senior Certificate."

- "3 In combining these subjects contemplated in subparagraph (2), the performance in the seven (7) subjects would be taken into consideration, provided that this combination meets the programme requirements of the National Senior Certificate as contemplated in paragraphs 9 and 10 of the policy document. National Senior Certificate: A Qualification at Level 4 on the National Qualifications Framework (NQF), promulgated in Government Gazette No. 27819 as Government Notice, No 744 of 20 July 2005."
- (c) the substitution of subparagraph (8) of paragraph 18 for the following subparagraph-

"(8) A candidate who did not write or complete the end-of year examination or part thereof due to the reasons stated in paragraph 2(b) and (d), [may be granted permission to write the supplementary examination only in the paper or papers that] with a valid reason, has the opportunity to write the supplementary examination for the specific examination question paper he or she did not write in the end-of-year-examination. However, should the candidate select to write the entire subject, even though he or she was absent for one or more examination question papers, the candidate should be allowed to exercise this option."

(d) the addition after subparagraph (9) to include the following subparagraph-

"(10) <u>Candidates who have not met the School-Based</u> <u>Assessment and Practical Assessment Task component</u> <u>requirements, may be allowed to improve their marks obtained in</u> <u>these two components, subject to satisfactory arrangements being</u> <u>made with the relevant accredited assessment body</u>."

Amendment of paragraph 2 of Annexure B

 Annexure B of the Policy is amended by the substitution of paragraph 2 of the following paragraph-

2. INCOMPLETE RESULTS

A learner's results are regarded as incomplete if he or she did not offer any of the School-Based Assessment [SBA] requirements <u>and/or</u> <u>Practical Assessment Task (PAT), a Practical Assessment or an Oral</u> <u>requirement</u> and no valid reason was provided. This implies that the learner did not submit [a specific] <u>all</u> assessment tasks specified for [internal assessment in the Subject Assessment Guidelines.]School-Based Assessment [in the], Practical Assessment Task (PAT), Practical Assessment or Oral assessment in the policy document, An addendum to the policy document, the National Senior Certificate: A qualification at Level 4 on the National Qualifications Framework (NQF), regarding the National Protocol for Assessment (Grades R - 12) and Subject Assessment Guidelines. In such an event, the code ["999"] <u>"444"</u> is indicated on the mark sheet. Such a candidate must [re-register for the subject to complete the SBA requirements.] repeat the subject in the subsequent examination but not the supplementary examination. If a candidate fails to do this, he or she will not qualify for a National Senior Certificate."

Amendment of paragraph 3 of Annexure B

4. Annexure B of the Policy is amended by the substitution of paragraph 3 of the following paragraph-

"3. OUTSTANDING MARKS

A mark is regarded as outstanding if, during the capturing process, the reason for the outstanding mark is not [completely] established. [A]The code, "777", is used to indicate an outstanding mark. The reason for [A] an outstanding [internal assessment] mark must be resolved as soon as possible and the "777" code replaced with either a mark or ["999"] a "444" code (absent) or a "999" code. In [a case] the event that the [learner] candidate was absent based on valid reasons, the outstanding School-Based [a]Assessment tasks and/or Practical Assessment Tasks (PAT), Practical Assessment or Oral must be submitted within the stipulated three-month period. Until this is done the result in this subject will be regarded as incomplete. In such an event the candidate cannot receive a result, since he or she has not satisfied the requirements of the National Senior Certificate. Should the candidate not submit the School-Based [a]Assessment tasks and/or Practical Assessment Tasks in the stipulated period, the code **[of]** "777" will be changed to["999"] "444". which will then be regarded as an incomplete result. A code "444" will be allocated when the candidate does not submit the required outstanding School Based Assessment and Practical Assessment Tasks."

Candidates who have failed the School-Based Assessment and Practical Assessment Task components, may be allowed to improve their marks obtained in the School-Based Assessment and Practical Assessment Task components, subject to satisfactory arrangements being made with the relevant accredited assessment body."

"National Senior Certificate: A Qualification at Level 4 on the National Qualifications Framework (NQF), promulgated as Government Notice No.27819 in *Government Gazette No. 744* of 20 July 2005."

The National Senior Certificate: A Qualification at Level 4 on the National Qualifications Framework (NQF) policy, promulgated in Government Gazette No. 27819 as Government Notice, No 744 of 20 July 2005 is hereby amended as follows:

Amendment of paragraph 6

- 6. This Policy is amended by the substitution of paragraph 6 of the following paragraph-
 - "6. Changing subjects in Grades 10, 11 and 12

(1) A learner may change [one or more] a maximum of two subjects in [his or her] Grade 10[year.], subject to the approval of the Principal of the school where the learner is registered.

(2) [Learners]<u>A learner may change [a subject] two subjects in</u> Grade 11[or 12 if the school deems it is in the best interests of the learner to change a subject. The school may take such a decision only after consultation with the Head of Department or his/her delegate.], subject to the approval of the Principal of the school where the learner is registered.

(3) In exceptional cases a learner may change one subject in Grade
12, provided it is done before 31 January of the Grade 12-year.

(4) Approval for changing a subject in Grade 12 must be obtained from the Head of the assessment body. The following must be furnished:

- (a) a letter of motivation from the learner's parent or guardian;
- (b) a letter from the Principal, either supporting or providing reasons for not supporting the change; and
- (c) a letter from the subject teacher, outlining the programme to be followed to assist the learner in covering those aspects of the curriculum statements for the previous grade that were not covered.

(5) The closing date for changing a subject or subjects in Grade 10 and 11 must be determined by the Head of the assessment body, based on the impact of the change on the internal assessment programme."

Amendment of paragraph 11

- 7. This Policy is amended by the addition after subparagraph (4) of the following subparagraph -
 - "11. Promotion and certification requirements

(4) A condonation of a maximum of one (1) subject will be applied if a candidate requires a maximum of 2%, either to obtain a pass at 30% or 40%. Such a condonation will be applied in only one subject, provided the application of the condonation allows the candidate to obtain the National Senior Certificate qualification".

Amendment of paragraph 12

8. This Policy is amended by the substitution of subparagraph (1) of paragraph 12 of the following subparagraph-

- "12. Concessions
 - (1) Immigrants

- (a) An immigrant candidate is:
 - (i) a child or a dependent of a diplomatic representative of a foreign government accredited in South Africa; or
 - (ii) a person who:
 - (aa) first enrolled at and entered a South African school in Grade 7 or a more senior grade, or
 - (bb) having begun his or her schooling at a school in South Africa, has attended school outside South Africa for two or more consecutive years after Grade 6 or its equivalent.
 - (iii) An irrimigrant candidate as contemplated above may offer only one (1) official language on at least First Additional Language Level and obtain a rating of 30% in that language, provided that another subject from Group B is offered in lieu of the one official language that is not offered, provided further that the irrimigrant candidate complies with the promotion requirements as contemplated in *paragraph 11(1)(e)*.
 - (iv) Instead of offering another subject from Group B in lieu of the one official language that is not offered, an immigrant candidate may offer his or her home language in lieu of that one official language, subject to the following:
 - (aa) offer his or her home language on the A-Level of the General Certificate of Education (GCE) of the United Kingdom, or an examination recognised by the Department of Education as equivalent to Home Language level for this purpose.
 - (bb) The marks as supplied by the concerned assessment body will be taken into account, or

if the actual marks are not available the results will be converted in accordance with the table below, with the proviso that the candidate may not offer two similarly named languages.

- (v) To be classified as an immigrant candidate, such a candidate must be in possession of:
 - (aa) the relevant official documentation issued by the Department of Home Affairs; and
 - (bb) the relevant official documentation issued by the school where the learner entered the South African school system for the first time."

Amendment of paragraph 14

- This Policy is amended by the addition after subparagraph (2) of the following subparagraph -
- "14. Assessment in Grade 12

The final mark is rounded down if the first decimal is less than 5 and rounded up if the decimal is 5 and above e.g. a final mark of 70,3 will be rounded down to 70 and a final mark of 70.6 is rounded up to 71."

Amendment of paragraph 16

10. This Policy is amended by the substitution of paragraph 16 of the following paragraph-

"16. Supplementary examinations

[(1)] <u>A supplementary examination will be granted under the following</u> conditions to a full-time, repeat and part-time candidate:

- [(a)](1) If a [Grade 12 full-time] candidate has not met the minimum promotion and certification requirements [in the final external examination, as contemplated in paragraphs 11 and 12], but requires <u>a maximum of</u> two subjects to obtain a National Senior Certificate, he or she may:
 - (a) Register for a maximum of two subjects for the supplementary examination in the following year. These two subjects must be, subject to subparagraph (c), offered [These] in the previous [October/November] end-of-year examination.

[A candidate who wishes to improve his/her performance in the end-of-year examinations may register for supplementary examinations in a maximum of two subjects.] Register for a supplementary examination in a maximum of two subjects. This option may only be exercised once by a part-time candidate, namely after completion of the National Senior Certificate, that is, his or her final end-of-year examination.

[If a Grade 12 part-time candidate or a private candidate has not met the minimum promotion and certification requirements as contemplated in *paragraphs 11* and 12 in his or her final external examination, but requires only one subject to obtain a National Senior Certificate, he or she may register for a maximum of one subject in the supplementary examinations in the following year. This subject must be a subject that the candidate sat for in the previous October/November examination.]

- (b) [In exceptional cases, candidates who are medically unfit and as a result are absent from one or more external examinations, may have the supplementary examination regarded as part of the same sitting.]Register for Life Orientation, which is internally assessed, as one of the two subjects to be registered for the supplementary examination in subparagraph (a). The re-assessment of Life Orientation must be completed within the period in which the supplementary examination is conducted.
- (c) [Admission to the supplementary examination is at the discretion of the Head of Department.] <u>Be allowed to</u> <u>combine the one or more repeated subjects with those already</u> <u>passed to enable them to obtain a National Senior Certificate</u> <u>in terms of the current National Senior Certificate</u> <u>requirements.</u>

[In cases (a) to (e) above the internal assessment of the Grade 12 year will be used, including practical/oral assessment marks where applicable.] That in the combination of the subjects, the performance in the seven (7) subjects would be taken into consideration, provided that the combination meets the programme requirements of the National Senior Certificate as contemplated in paragraphs 9 and 10 of the policy document. National Senior Certificate: A Qualification at Level 4 on the National Qualifications Framework (NQF), promulgated in Government Gazette No. 27819 as Government Notice, No 744 of 20 July 2005."

- <u>"(2) If a candidate is medically unfit and, as a result, is absent from one</u> <u>or more external examinations, he or she may register for the</u> <u>supplementary examination.</u>
- (3) A candidate who does not satisfy the minimum higher education requirements or the requirements for the specific occupation in the end-of-year examination may be allowed to register for the supplementary examination in the year following the end-of-year National Senior Certificate examination, in a maximum of two subjects, subject to the following:
 - (a) a candidate who is one requirement short of meeting the minimum admission requirements for Higher Certificate, Diploma and Bachelor's degree programmes requiring a National Senior Certificate; or
 - (b) a candidate that provides documentary evidence that he or she qualifies for admission to a higher education institution or for an occupation, but does not satisfy the higher education faculty requirements or the requirements for the specific occupation. For this purpose, the end-of-year and the

supplementary examinations will be regarded as one examination sitting.

- (4) If there is a death in the immediate family of a candidate, or other special reasons for the candidate's absence, he or she may register for the supplementary examination.
- (5) In cases contemplated in *subparagraphs* (1) to (4) above, the School-Based Assessment mark of the Grade 12-year will be used, including practical or oral assessment marks where applicable, in order to meet the internal assessment and external examination requirements.
- (6) In a case where an irregularity is being investigated, provisional enrolment for the supplementary examination may be granted to the candidate concerned, pending the outcome of the investigation.
- (7) A candidate who did not write or complete the end-of year examination with a valid reason, has the opportunity to write the supplementary examination for the specific examination question paper he or she did not write in the end-of-year-examination. However, should the candidate select to write the entire subject, even though he or she has been absent for one or more examination question papers, the candidate should be allowed to exercise this option."

Amendment Annexure C

11. This Policy is amended by the substitution of Annexure C of the following Annexure:

"ANNEXURE C

RECOGNITION OF SUBJECTS NOT LISTED IN THE NATIONAL CURRICULUM STATEMENT GRADES 10-12[(GENERAL)]

C.1 THE STATUS OF SUBJECTS OFFERED BY OTHER ASSESSMENT BODIES

[Candidates]Learners may offer a maximum of one subject developed by accredited assessment bodies other than the Department of Education, provided that such a subject is accommodated in national education policy. A maximum of 20 credits may be allocated to such subjects. Accredited providers that wish to offer their subjects as part of the National Curriculum Statement Grades 10-12 may do so, subject to the approval of the Department of Education.

The subjects listed in *paragraph C2* are approved subjects from other accredited assessment bodies [during the interim period]._Only in exceptional cases will additional subjects in this category be considered by the Department of Education.

Since the rating scale of the external examining body is not in accordance with that of the National Senior Certificate – the rating (1 - 7) will not be indicated on the statement of results and on the final certificate issued by Umalusi.

The actual mark obtained by the candidate will be reflected on the Statement of Results, with an asterisk denoting that this subject was offered by an external assessment body and that the pass mark in this subject is stipulated by the assessment body.

Regulations pertaining to the Conduct, Administration and Management of Assessment for the National Senior Certificate, promulgated as *Government Notice, No. R*872 in *Government Gazette No. 31337* of 29 August 2008

The Regulations pertaining to the Conduct, Administration and Management of Assessment for the National Senior Certificate, promulgated as *Government Notice*, *No. R872* in *Government Gazette No. 31337* of 29 August 2008 is hereby amended as follows:

Amendment of Regulation 7

1. Regulation 7 is amended by the substitution of subregulation (5) of the following subregulation-

"(5) The School-Based Assessment, <u>Practical Assessment Task</u> [mark] (PAT), <u>Practical Assessment and Oral marks</u> obtained by a [repeat candidate] <u>candidate</u> in his or her last National Senior Certificate examinations will be valid for a period of [three (3)] <u>two (2)</u> years after the completion of the first National Senior Certificate examinations written by the candidate."

Amendment of Regulation 8

- 2. Regulation 8 is amended in the following way:
 - (a) by the substitution of subregulation (2) of the following subregulation-
 - "(2) A learner may change [one] two subjects in Grade 11, subject to the approval of the Principal of the school where the learner is registered."

- (b) by the addition after subregulation 5 of the following subregulations-
 - "(6) <u>National Senior Certificate candidates who sat for the National</u> <u>Senior Certificate examination and who wish to repeat the</u> <u>whole National Senior Certificate qualification obtained, may</u> <u>do so provided that the candidate</u>:
 - (a) provides documentary evidence that he or she has offered the National Senior_Certificate; and
 - (b) registers with an accredited assessment body with the aim of ensuring that all the School-Based Assessment, Practical Assessment Task (PAT), Practical Assessment and Oral requirements for all subjects that will be offered for the improved qualification are met.
 - (7) <u>National Senior Certificate candidates who sat for the National Senior Certificate examination and who wish to register for a subject not offered in the said National Senior Certificate examination with the aim of meeting faculty requirements at a higher education institution, may do so, provided that the candidate:</u>
 - (a) sat for the National Senior Certificate examination in the previous year;
 - (b) does not change more than two subjects sat for in the National Senior Certificate examination;
 - (c) provides documentary evidence that he or she has met the School-Based Assessment, Practical Assessment Task (PAT), Practical Assessment and Oral requirements in the subject to be offered;
 - (d) has met all the outstanding School-Based Assessment and Practical Assessment requirements for the subject offered; and

(e) completes the new subject within a two-year period."

Amendment of Regulation 18

- 3. Regulation 18 is amended in the following way:
 - (a) by the substitution of the introduction of the following introduction-

"A supplementary examination will be granted under the following conditions to a full-time, repeat and part-time candidate:"

(b) by the substitution of subregulations (1), (2) and (3) of the following subregulation-

"(1) If a candidate has not met the minimum promotion and certification requirements [in the final external examination], but requires a maximum of two subjects to obtain the National Senior Certificate, he or she may:

- (a) [r]Register for a maximum of two subjects for the supplementary examination in the following year. These subjects, <u>subject to subparagraph (c)</u>, <u>must be</u> [These] subjects that [the candidate] <u>he or she</u> sat for in the previous end-of-year examination. <u>This option may only be exercised</u> <u>once by a part-time candidate, namely after completion of the</u> <u>National Senior Certificate, that is his or her final end-of-year</u> <u>examination.</u>
- (b) Register for Life Orientation, which is internally assessed, as one of the two subjects to be registered for the supplementary examination in subregulation (a). The re-assessment of Life Orientation must be completed within the period in which the supplementary examination is conducted."

"2 Candidates that repeat one or more subjects must be allowed to combine their subjects based on the current National Senior Certificate requirements to obtain a National Senior Certificate."

"3 In combining these subjects contemplated in subparagraph (2), the performance in the seven (7) subjects will be taken into consideration, provided that it meets the programme requirements of the National Senior Certificate as contemplated in paragraphs 9 and 10 of the policy document . National Senior Certificate: A Qualification at Level 4 on the National Qualifications Framework (NQF), promulgated in Government Gazette No. 27819 as Government Notice, No 744 of 20 July 2005."

(c) by the substitution of subregulation (7) of the following subregulation-

"(7) A candidate who did not write or complete the end-of year examination with a valid reason has the opportunity to write the supplementary examination for the [subject] specific examination guestion paper that he or she did not write in the end-of-year-examination. However, should the candidate select to write the entire subject, even though he or she has been absent for one or more examination question papers, the candidate should be allowed to exercise this option."

Amendment of Annexure C

- Annexure A of the Regulations is amended by:
 - (a) the substitution of paragraph (2) of the following paragraph-

"2. INCOMPLETE RESULTS

A learner's results are regarded as incomplete if he or she did not offer any component of the School-Based Assessment and/or a Practical Assessment Task (PAT), a Practical Assessment or an Oral mark and no valid reason was provided. This implies that the learner did not submit all assessment tasks specified for School-Based Assessment [in the], Practical Assessment Task (PAT), Practical Assessment or Oral requirements in the policy document, An addendum to the policy document, the National Senior Certificate: A qualification at Level 4 on the National Qualifications Framework (NQF), regarding the National Protocol for Assessment (Grades R - 12) and Subject Assessment Guidelines. In such an event, the code "444" is indicated on the mark sheet. Therefore the candidate cannot receive a result in the subject, since he or she has not satisfied the requirements of the National Senior Certificate and will not qualify for a National Senior Certificate. In such an event, the code ["999"]"444" is indicated on the mark sheet. Such a candidate must repeat the subject in the subsequent examination, but not the supplementary examination. If a candidate fails to do this, he or she will not qualify for a National Senior Certificate."

(b) the substitution of paragraph (3) of the following paragraph-

"3. OUTSTANDING MARKS

A mark is regarded as outstanding if, during the capturing process, the reason for the outstanding mark is not [completely] established.

The code, "777", is used to indicate an outstanding mark. An outstanding [internal assessment] mark must be <u>finalised</u> [resolved] as soon as possible and the "777" code replaced with either a mark or a ["999"] "444" code (absent) *or a "999" code*.

In the event that the [learner] <u>candidate</u> was absent, based on valid reasons, <u>code "999" will be captured</u>. **[t]** The outstanding School-Based A[a]ssessment [tasks], and/or Practical Assessment Tasks (PAT), Practical Assessment or Oral mark must be submitted within the stipulated three-month period. [the code "999"] The result in the subject will be regarded as incomplete. In such an event the candidate cannot receive a result, since he or she has not satisfied the requirements of the National Senior Certificate. Should the candidate_not submit the <u>School-Based A[a]</u>ssessment tasks <u>and/or Practical</u> Assessment Tasks in the stipulated period, the code "777" will be changed to ["999"] "444".

<u>Candidates who have not met the School-Based Assessment and</u> <u>Practical Assessment Task component requirements, may be</u> <u>allowed to improve their marks obtained in the School-Based</u> <u>Assessment and Practical Assessment Task components, subject to</u> <u>satisfactory arrangements being made with the relevant accredited</u> <u>assessment body</u>."

Amendment of Annexure M

7. Annexure M of the Regulations is amended by the addition of an additional clause to subparagraph (10) of paragraph 5-

SHORT TITLE AND COMMENCEMENT

8. These Regulations may be cited as the Amendment Regulations Pertaining to the Conduct, Administration and Management of Assessment for the National Senior Certificate, and will come into effect on the date of publication in the Government Gazette.
