# ACT

**To amend the Local Government: Municipal Property Rates Act, 2004, so as to provide for the extension of the period of validity of a valuation roll and supplementary valuation roll that was in force before the commencement of the Act; and to provide for matters connected therewith.**

**B**E IT ENACTED by the Parliament of the Republic of South Africa, as follows:—

**Amendment of section 89 of Act 6 of 2004**

1. Section 89 of the Local Government: Municipal Property Rates Act, 2004 (Act No. 6 of 2004), is hereby amended by the substitution for subsection (3) of the following subsection: 5

“(3) [**This**] The operation of this section lapses [**four**] six years from the date of commencement of this Act, and from that date any valuation roll or supplementary valuation roll that was in force before the commencement of this Act may not be used.”. 10

**Transitional arrangement**

2. Any action taken or performed and finalised in terms of section 89 of the Local Government: Municipal Property Rates Act (Act No. 6 of 2004), on or after 1 July 2009, shall be deemed to have been taken or performed and finalised in terms of this Act and is hereby validated and declared lawful. 15

**Short title and commencement**

3. This Act is called the Local Government: Municipal Property Rates Amendment Act, 2009, and is deemed to have come into operation on 1 July 2009.

1. Ngakho-ke isigaba sama-89 soMthetho woHulumeni baseKhaya: wokuKhokhwa kweNtela yeNdawo yoMasipala, sichibiyelwe ngokufaka endaweni yaso isigatshana 5  
 sesi-(3) salesi sigatshana esilandelayo:

“(3) [Lesi] Ukusebenza kwalesi sigaba kuzofika emaphethelweni eminyakeni [emine] eyisithupha kusukela ngosuku okuyoqala ngalo ukusebenza kwalo Mthetho, futhi kusukela ngalolo suku nanoma yiluphi uhlu lwempahla ehloliwe noma uhlu olwengezayo lwempahla ehloliwe olwaluphoqiwe ngaphambi kokuqala 10  
 ukusebenza kwalo Mthetho akumele lusetshenziswe.”

2. Nanoma iziphi izinyathelo ezithathiwe noma ezenziwe futhi kwathathwa izinqumo ngazo ngokwemigomo yesigaba sama-89 soMthetho woHulumeni baseKhaya: wokuKhokhwa kweNtela yeNdawo yoMasipala (uMthetho wesi-6 wezi-2004), mhla lu 15  
 -1 kaJulayi 2009 noma ngemuva kwalolu suku, singakaqali ukusebenza isichibiyelo kumele zithathwe njengezenziwe ngokwemigomo yalo Mthetho futhi ngalokhu ziyaqinisisekiswa futhi zizothathwa njengezisemthethweni.
