**PUBLICATION OF EXPLANATORY SUMMARY OF SOUTH AFRICAN POST OFFICE
BILL, 2010**

The Minister of Communications intends to introduce the South African Post Office Bill, 2010 in the National Assembly shortly. The explanatory summary of the Bill is hereby published in accordance with Rule 241(1)(c) of the Rules of the National Assembly.

Explanatory summary of the Bill: To provide for the continued corporate existence of the South African Post Office and its subsidiaries; to provide for its governance and staff; to provide for the separation of accounts between reserved and unreserved postal services; and to provide for matters connected therewith.

**PUBLIKASIE VAN VERDUIDELIKENDE OPSOMMING VAN SUID-AFRIKAANSE
POSKANTOOR WETSONTWERP, 2010**

Die Minister van Kommunikasie beoog om die Suid-Afrikaanse Poskantoor Wetsontwerp, 2010 eersdaags in die Nasionale Vergadering in te dien. Die verduidelikende opsomming van die Wetsontwerp word hierby ooreenkomstig Reël 241(1)(c) van die Reëls van die Nasionale Vergadering gepubliseer.

Verduidelikende opsomming van die Wetsontwerp: Om voorsiening te maak vir die voortgesette korporatiewe bestaan van die Suid-Afrikaanse Poskantoor en sy filiaalmaatskappye; om voorsiening te maak vir sy beheer en personeel; om voorsiening te maak dat die rekeninge van die gereserveerde en ongereserveerde posdienste afsonderlik weergegee word; en om voorsiening te maak vir aangeleenthede wat daarmee in verband staan.
