AMENDMENT OF DECLARATION NO. 1356 OF 2008.

By virtue of section 40(1)(b) of the South African National Roads Agency Limited and the National Roads Act, 1998 (Act No. 7 of 1998), I hereby amend Declaration No. 1356 of 2008 by de-declaring the section of road from a point on the centre line of National Road N4 section 7X in line with point R393 on Plan No. P662/08 as declared in terms of Government Gazette No. 31705 of 17 December 2008, through the town of Nelspruit up to the eastern road reserve boundary of Dr Enos Mabuza Drive (N4/7), as a National Road.
