#### REGULATIONS: AMENDMENTS

The Minister of Agriculture, acting under section 20 of the Genetically Modified Organisms Act, 1997 (Act No. 15 of 1997), has made the following regulations in the Schedule.

#### SCHEDULE

##### *Definition*

1. In this Schedule "the Regulations" means the regulations published by Government Notice No. R. 1420 of 26 November 1999, as amended by Government Notice Nos. R. 828 of 21 June 2002, R. 576 of 2 May 2003 and R. 495 of 23 April 2004, R. 478 of 27 May 2005, R. 130 of 17 February 2006, R. 41 of 26 January 2007, R. 172 of 15 February 2008 and R. 46 of 30 January 2009.

**HEALTH PROFESSIONS ACT, 1974: AMENDMENT**

**AMENDMENT OF ETHICAL RULES OF CONDUCT FOR PRACTITIONERS REGISTERED  
UNDER THE HEALTH PROFESSIONS ACT, 1974:**

The Health Professions Council of South Africa intends, under section 61(5) of the Health Professions Act, 1974 (Act No. 56 of 1974), to amend the Ethical Rules promulgated as Government Notice No. R.717 of 4 August 2006 as amended by Government Notice No. R 68 of 2 February 2009 as reflected in the schedule.

Interested persons are invited to submit any substantiated comments or representations in writing on the proposed amendments to the Registrar, Health Professions Council of South Africa, P.O. Box 205, Pretoria 0001 (for the attention of the General Manager: Professional Boards) within three months from date of publication of this Notice.

**SCHEDULE**

**Definitions**

1. In this Schedule, "**Ethical Rules**" means the Ethical Rules of conduct for practitioners registered under the Health Professions Act, 1974, promulgated as Government Notice No. R. 717 of 4 August 2006 and published in Government Gazette No. 29079, as amended by Government Notice No. R 68 of 2 February 2009 and any word or expression to which a meaning has been assigned in the Ethical Rules shall have that meaning.

**Amendment of Annexure 7**

2. Annexure 7 of the Ethical Rules is hereby amended by the insertion of the following rule after Rule 7:

**Performance of professional acts by intern medical orthotist and prosthetist**

- 7A. An Intern Medical Orthotist and Prosthetist -
- (a) shall perform professional acts only under the supervision of a registered medical orthotist and prosthetist in accordance with the guidelines of the Board;
  - (b) shall limit acts referred to in 7A(a) to acts related to his or her education and training as part of a structured internship programme;
  - (c) shall not act as a locum or conduct an independent private practice; and

- (d) who has completed internship, shall not perform any professional acts until he or she has satisfied all the requirements for registration as a medical orthotist and prosthetist and has been registered as such.

#### **Amendment of Annexure 8**

3. Annexure 8 of the Ethical Rules is hereby amended by the deletion of sub-rule (2) of rule 1.

#### **Amendment of Annexure 9**

4. Annexure 9 of the Ethical Rules is hereby amended by the insertion of the following rule after Rule 7:

#### **Performance of professional acts by intern biokineticist**

##### **7A. An Intern Biokineticist -**

- (a) shall perform professional acts only under the supervision of a registered biokineticist and in accordance with the guidelines of the Board;
- (b) shall limit acts referred to in 7A(a) to acts related to his or her education and training as part of a structured internship programme;
- (c) shall not act as a locum or conduct an independent private practice; and
- (d) who has completed internship, shall not perform any professional act until he or she has satisfied all the requirements for registration as a biokineticist and has been registered as such.
