<p>Effective Date: 8 July 2009</p> <p>The Board orders:</p> <ol style="list-style-type: none"> <li>1. AC Industrials be barred from tendering under the auspice of the CIDB for a period of 3 months from the date of the Panel’s final decision.</li> <li>2. AC Industrials to pay a fine of R75 000.00 over a period of 12 months, commencing from the date of the panel’s final decision.</li> <li>3. AC Industrial’s current grading designation on the CIDB register of contractors be removed, however it be allowed to immediately re-apply for registration of the desired grading designation from the start.</li> <li>4. AC Industrials not to be considered for an upgrade to a higher designation on the CIDB register post the barring period referred to in 1 above and until the Board is satisfied that the imposed fine referred to in 2 above has been paid in full.</li> <li>5. AC Industrials be permitted to complete all its outstanding projects under the auspices of the CIDB during the barring period referred to in 1 above.</li> </ol>
