NOTICE OF INTENT

NATIONAL ROAD N4: SECTION 7: NOTICE OF INTENTION TO DECLARE THAT SECTION OF THE NATIONAL ROAD N4 SECTION 7 AS DESCRIBED BELOW AS A TOLL ROAD


In terms of Section 27(4)(a) of The South African National Road Agency Limited and National Roads Act, 1998 (Act No. 7 of 1998), The South African National Roads Agency Limited hereby gives notice of its intention to recommend to the Minister of Transport the declaration of the following National Road section as a toll road:

A Portion of existing National Road N4: Section 7 commencing from a point 32.2m west of points L95 and R94 of plan No. P628/07 on the farm Friedenheim 282 – JT where the previous notice of intent ends as declared in terms of Government Gazette No. 32314 of 12 June 2009, from where it proceeds in a easterly direction along the existing National Road N4 section 7 up to points L220 and R259 of Plan No.628/07 on the farm Karino Farm 134 –JU, excluding the section from point R134 to point R184 and declared as a national road in terms of Government Gazette No: 30745 of 8 February 2008.

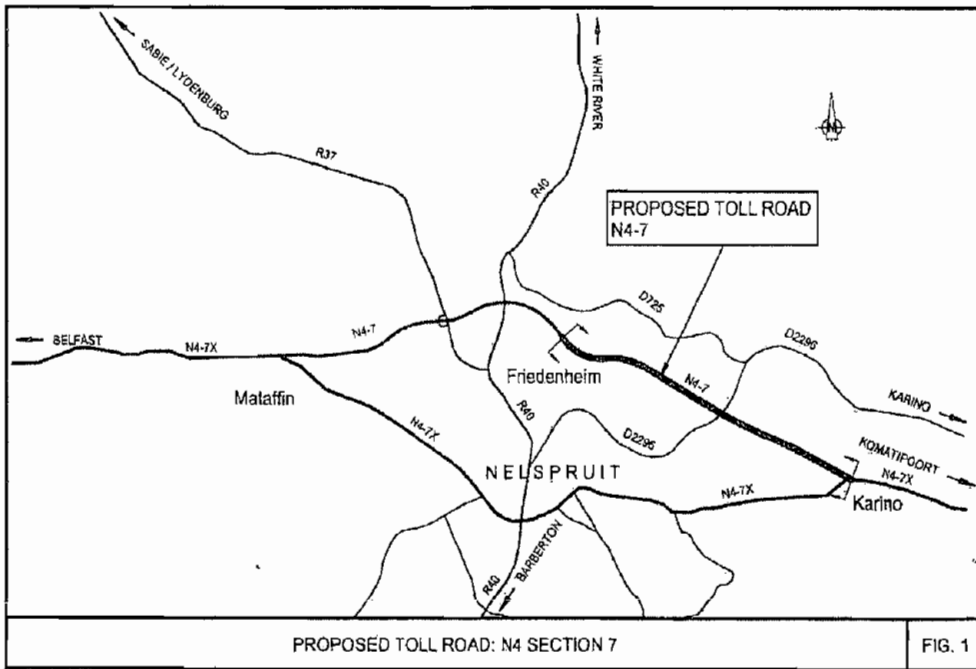
In terms of Section 27(4)(a)(ii) of the said Act all interested persons are hereby invited to comment and make written representations, by 24 April 2010 ("closing date"), being a date not less than 30 days from the date of this notice. All written representations must reflect the details of the proposed toll road in question and as described in this notice and must be addressed to the Regional Manager: Northern Region, The South African National Roads Agency Limited ("SANRAL") and be:

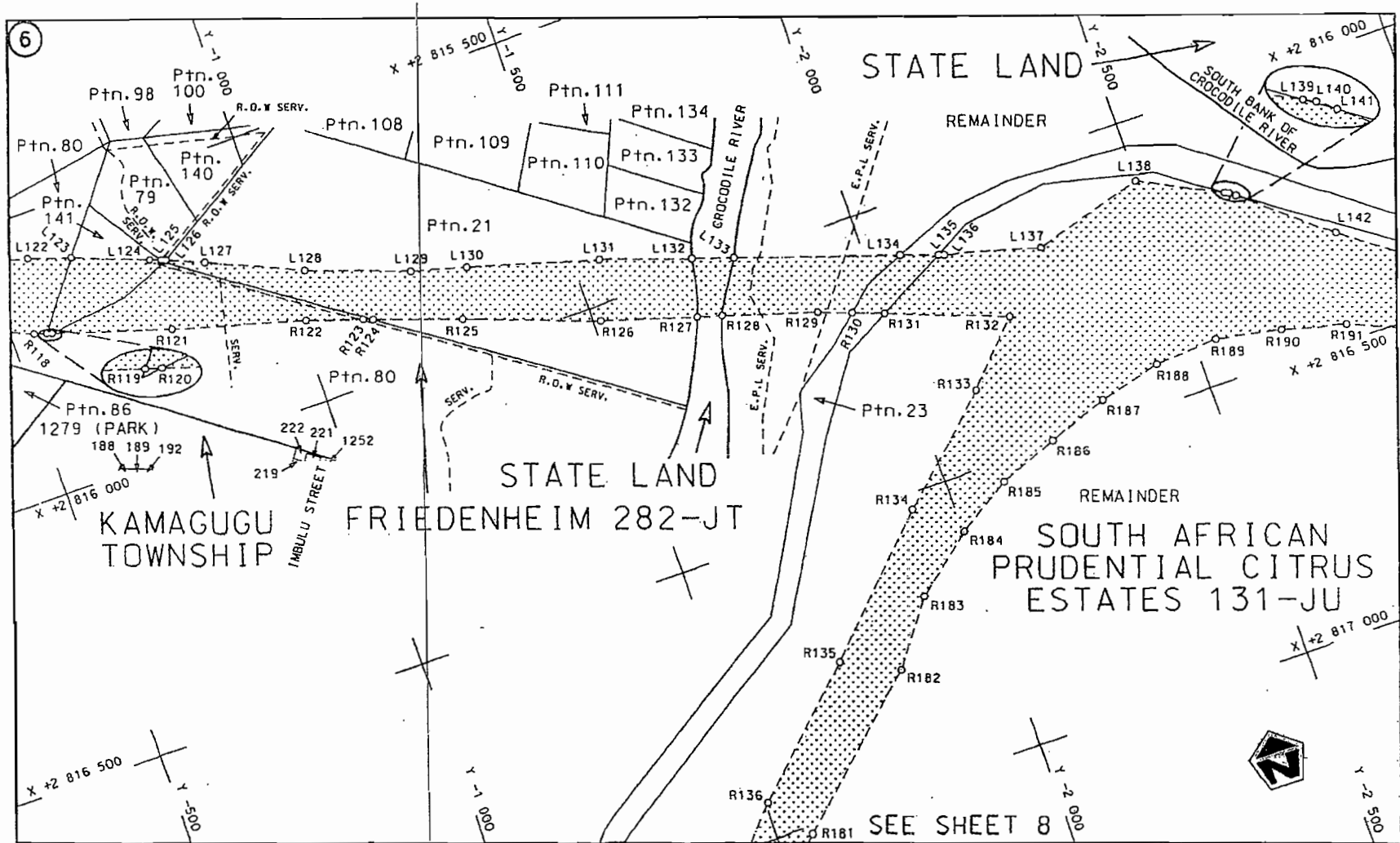
- telefaxed to the following number 012 348 1512; and/or
- posted to the following postal address, Private Bag X17, Lynwood Ridge, 0040, save that SANRAL shall not be obliged to take into account any representations sent by post but not actually received and processed by SANRAL by the closing date, for whatever reason; and/or
- delivered to SANRAL, Northern Region, 38 Ida Street, Menlo Park, 0081 and deposited in the dedicated box available for purposes of written representations, save that SANRAL shall not be obliged to take into account any written representations delivered to the aforementioned address but which have not been deposited in the box provided for this purpose.


SANRAL shall only consider written representations forwarded to them in the manner contemplated above and which are actually received and processed by the closing date. All other representations may be disregarded.

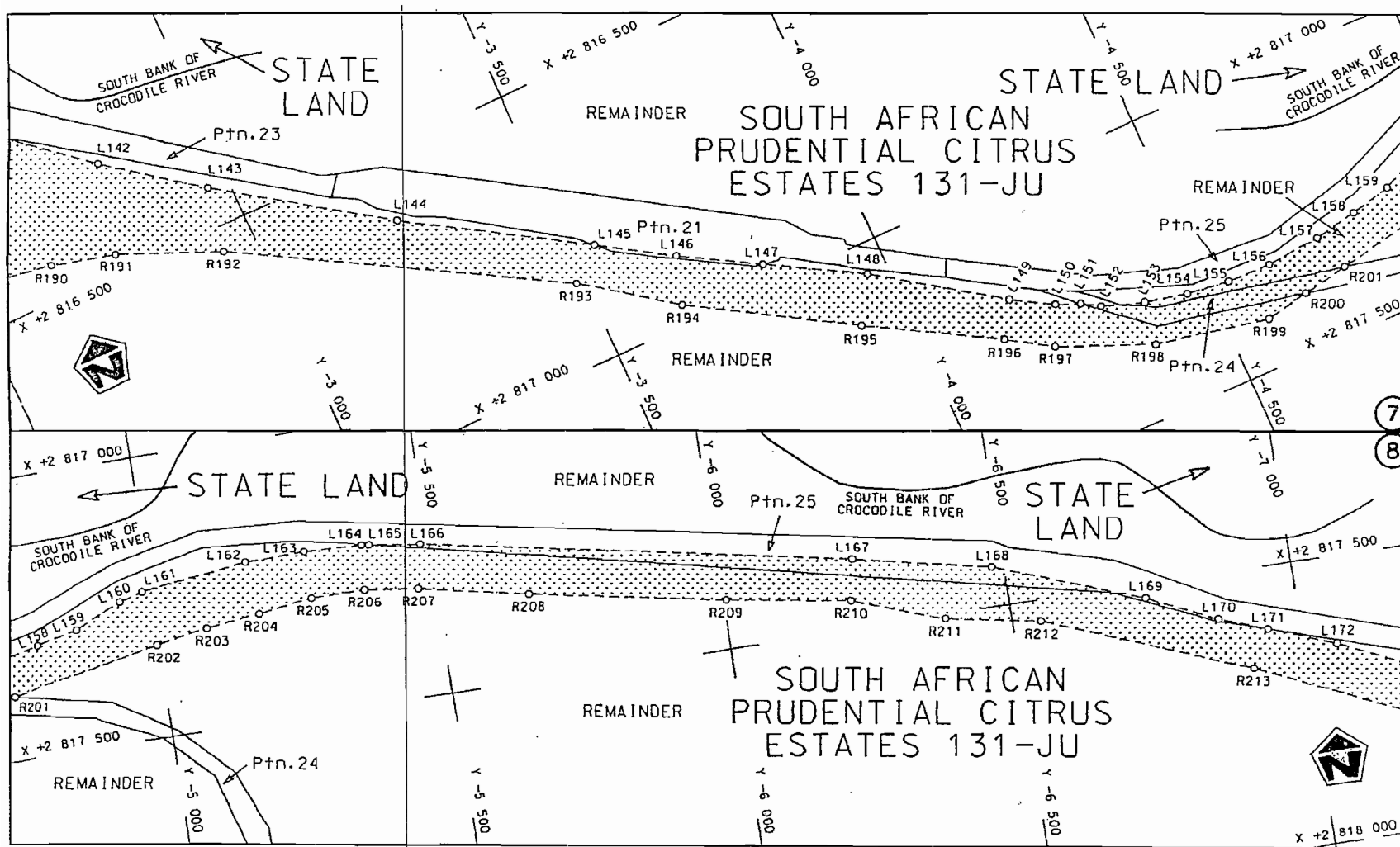




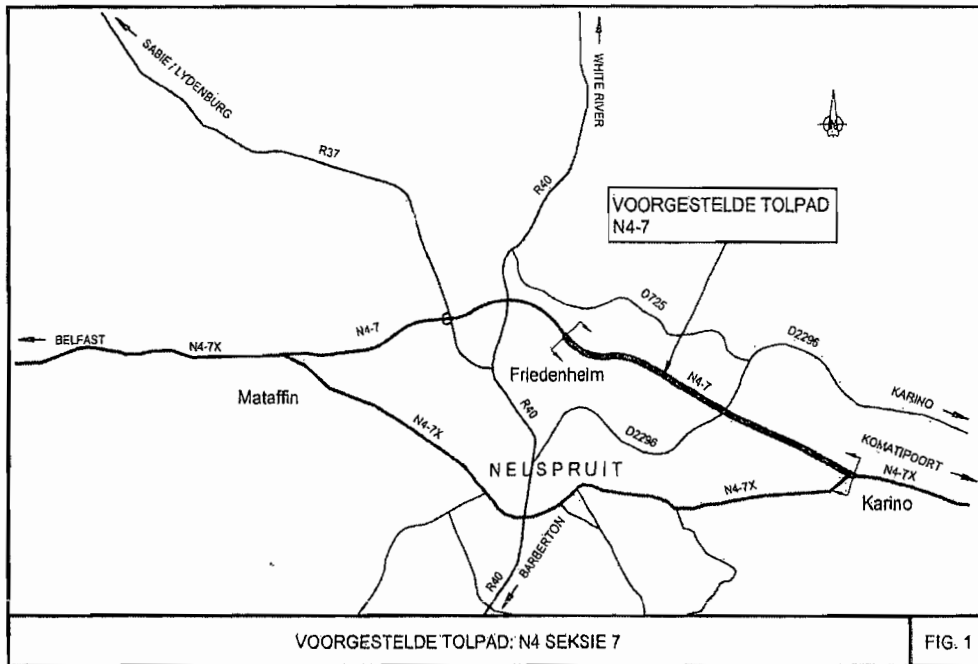

P628/07 op die plaas Friedenheim 282 - JT waar die vorige kennisgewing van voorneme eindig soos verklaar in Staatskoerant no. 32314 van 12 Junie 2009, vanwaar dit verder gaan in 'n oostelike rigting op die bestaande Nasionale Pad N4 seksie 7 tot by punte L220 en R259 van Plan no. P628/07 op die plaas Karino Farm 134 - JU, uitsluitende die gedeelte vanaf punt R134 tot punt R184 en as nasionale pad verklaar is in Staatskoerant no: 30745 van 8 Februarie 2008.

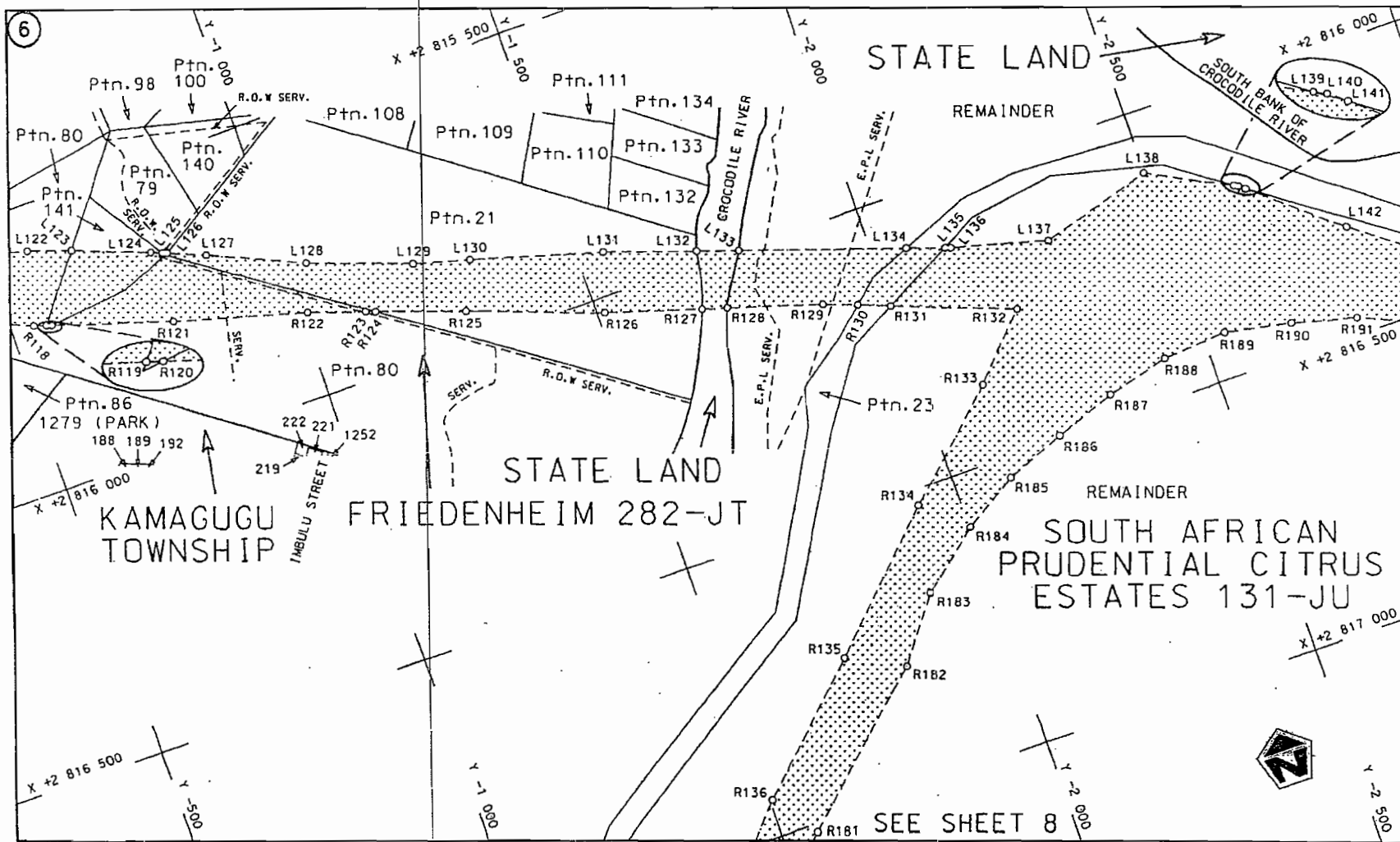


- gefaks word na die volgende nommer 012 348 1512; en/of

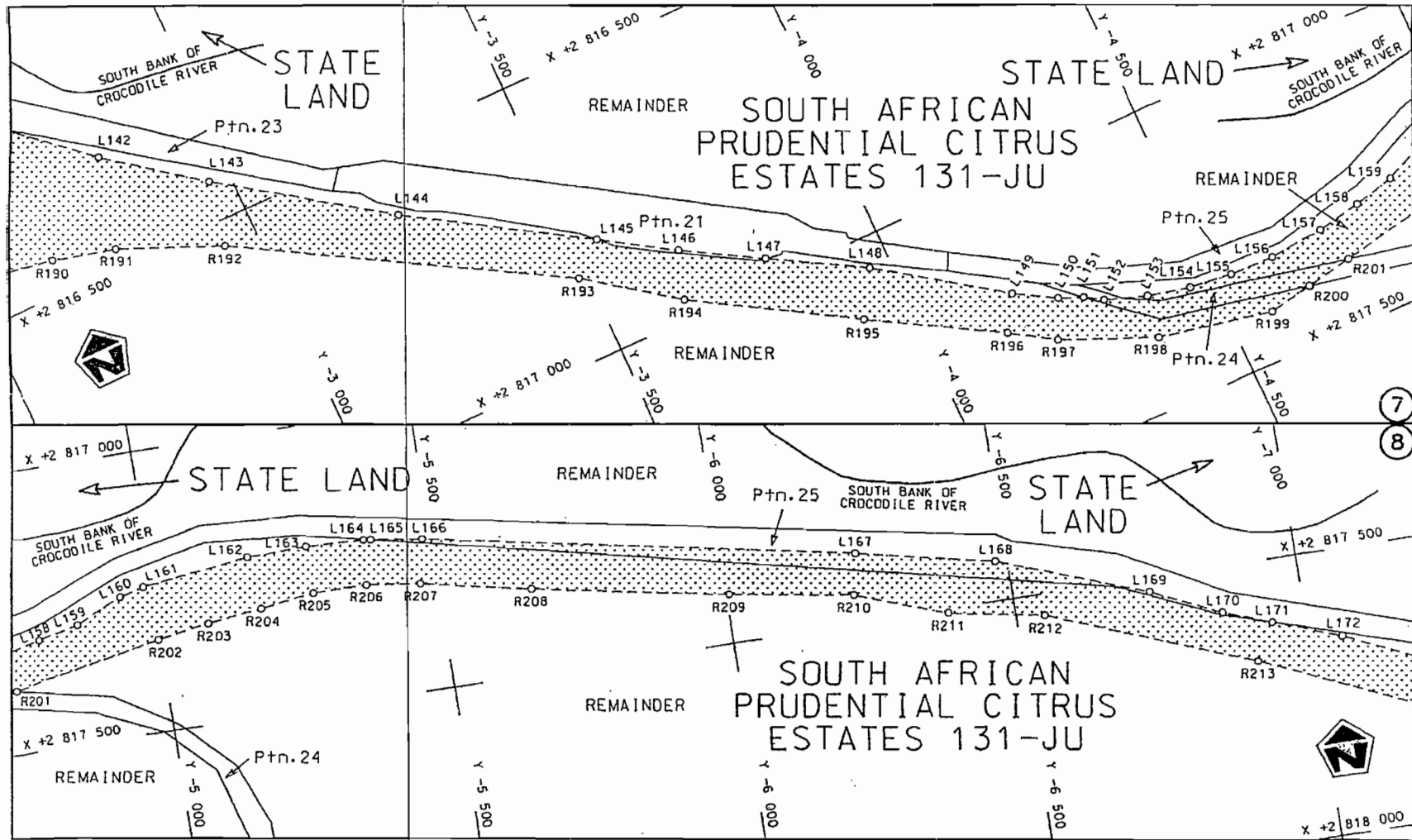


