NATIONAL LAND TRANSPORT ACT, 2009 (ACT NO. 5 OF 2009)

**AMENDMENT OF THE NATIONAL LAND TRANSPORT REGULATIONS, 2009**

I, S`busiso Joel Ndebele, Minister of Transport, do hereby intend to make amendments to the National Land Transport Act (Act No. 5 of 2009) Regulations published in Government No. R.1208 of 17 December 2009.

**SCHEDULE****Amendment of regulation 29 of the Regulations**

1. Regulation 29 of the regulations is hereby amended by the addition of the following sub-regulation (6) after sub regulation (5);

“(6) As from a date to be determined by the Minister by notice in the Gazette, no person may operate a courtesy service contemplated in sub-regulation (2) without being in possession of an operating licence.”

**Short title and commencement**

3. These regulations are called the Amendment of the National Land Transport Regulations, 2009 and will come into operation on the date of their publication in the *Gazette*.
