GENERAL NOTICE – INDIVIDUAL ECNS AND ECS LICENSEE DATABASE AUDIT

- (1) In January 2010, the Authority sent letters to holders of individual ECNS and/or ECS licences, requesting the licensees to provide updated contact details to allow the Authority to monitor compliance with the various regulations.
- (2) The Authority received responses from some and not all of the licensees to whom letters were sent.
- (3) Council of the Authority has approved the publication of the attached list to allow licensees to verify the details contained therein and to afford all licensees the opportunity to update the relevant details.
- (4) Licensees are requested to submit updated contact details where such are missing/incorrect as shown in the table below.
- (5) In terms of the Standard terms and conditions for class and individual licences, (Notice 1138 in Government Gazette 30530 of 30 November 2007 and Notice 1122 in Government Gazette 30512 of 30 November 2007, respectively) regulation 6 in both schedule 2 and 3 of said regulations require that class ECS licensees commence operations within 6 months from the effective date, being the date of issue of the licence. The same requirement applies to class ECNS licences whilst the applicable period for individual ECNS licences is 12 months from the effective date.
- (6) The Authority requires that Licensees who are shown as not having complied/responded are requested to submit the following information/documentation that will enable

the Authority to verify compliance with said regulation. The information may include but is not limited to:

- a. invoices/receipts/proof of procured services/network elements,
- b. client lists,
- c. financial statements,
- d. Coverage map of rolled out network,
- e. Such other relevant documentation.


