The Minister of Higher Education and Training has in terms of section 13 (2) of the Skills Development Act 1998, with effect from the date of publication of this notice as set out in the Schedule hereto, amended the Constitution of the ETDP SETA that was published in Government Gazette Notice No. 445 of 15 May 2006.

SCHEDULE

Amend clause 23 with the following: “the Board consists of the twenty members”

Amend sub-clause 25.1 to 25.3 with the following: “Sub-clause 25.1: as per Schedule C of this Constitution”

To remove the following from sub-clause 25.4:

“25.1, to 25.3 “

Amend clause 73.1 and 73.2 with the following:

73.1. The Higher Education and Research Chamber;

73.2. The Further Education and Training (FET) and Technical Vocational Education and Training (TVET) Chamber;

73.3. The Early Childhood Development (ECD) and Adult Basic Education (ABET) Chamber;

73.4. The Schooling Chamber (Private and Public); and

73.5. The Education, Training and Development Practices and Provisioning Chamber.
