PETROLEUM PRODUCTS ACT, 1977 (ACT No. 120 OF 1977)

REGULATIONS IN RESPECT OF THE SINGLE MAXIMUM NATIONAL RETAIL PRICE FOR ILLUMINATING PARAFFIN

- I, Ms. E D Peters, Minister of Energy, under section 2(1)(c) of the Petroleum Products Act, 1977 (Act No. 120 of 1977), determine that a maximum retail price for illuminating paraffin (excluding the price of any form of packaging) will become effective on the first Wednesday of each month.
- The maximum retail price for illuminating paraffin, excluding the price of any form of packaging, for the period 01 September 2010 to 05 October 2010 will be 679.0 c/l.

3. Commencement

These regulations shall come into operation at 00:01 on 06 October 2010.

AMENDMENT OF THE REGULATIONS IN RESPECT OF PETROLEUM PRODUCTS

SCHEDULE

1 Definitions
