

**AMENDMENT OF REGULATIONS FOR THE CONTROL OF USE OF
VEHICLES IN THE COASTAL ZONE**

1. In this schedule "the Regulations" means the regulations published under Government Notice No. R.1399 of 21 December 2001, as amended by Government Notice No. R. 1426 of 7 December 2004.

Amendment of Regulation 1 of Regulations

2. Regulation 1 of the regulations is hereby amended by the substitution for the definition of "Deputy Director-General" for the following definition:

"Deputy Director-General means the Deputy Director-General of the Department of Environmental Affairs within the branch responsible for coastal matters".
