DETERMINATION OF SALARIES OF PROSECUTORS AND SPECIAL INVESTIGATORS UNDER SECTION 18(1) AND 19C(1) OF THE NATIONAL PROSECUTING AUTHORITY ACT, 1998

I, Jeffrey Thamsanqa Radebe, Minister for Justice and Constitutional Development, acting under the National Prosecuting Authority Act, 1998 (Act No. 32 of 1998), and in consultation with the National Director of Public Prosecutions and after consultation with the Minister for Public Service and Administration and with the concurrence of the Minister of Finance, hereby determine, as indicated in Schedule 1, new salaries for prosecutors and special investigators in terms of which the salary ranges specified in Column 2 shall, with effect from 1 July 2010, be applicable and payable to prosecutors and special investigators.
