CURRENCY AND EXCHANGES ACT, 1933

AMENDMENT OF EXCHANGE CONTROL REGULATIONS

The President has under section 9 of the Currency and Exchanges Act, 1933 (Act No. 9 of 1933), made the regulations in the Schedule.

SCHEDULE

Definition

1. In these regulations "the Regulations" means the Regulations published by Government Notice No. R.1111 of 1 December 1961, as amended by Government Notices Nos. R.872 of 3 June 1966, R.1647 of 21 October 1966, R.650 of 19 April 1968, R.1555 of 15 August 1975, R.355 of 5 March 1976, R.357 of 20 February 1981, R.2610 of 30 November 1984, R.157(P) of 1 September 1985, R.2868 of 23 December 1985, R.957 of 4 May 1987, R.1416 of 23 June 1987, R.224 of 19 February 1988, R.881 of 29 April 1988, R.1472 of 18 July 1988, R.427 of 12 March 1995, R.1022 of 1 August 1997, R.885 of 23 July 1999 and R.999 of 1 November 2010.

Amendment of regulations 6(10)(a), 6(10)(b) and 6(10)(c) of the Regulations

2. Regulations 6(10)(a), 6(10)(b) and 6(10)(c) of the Regulations are hereby amended by the substitution of subregulations (10)(a), (10)(b) and (10)(c) for the following subregulations:
 - "(a) Subject to any exemption which may be granted by the Treasury, no person shall export goods from the Republic, unless the relative bill of entry export in respect of such goods is duly completed and signed by the consignor or a person duly authorised by the consignor.
 - (b) The Treasury may direct that the said bill of entry export shall be completed in respect of any commodity or article, irrespective of its value.
 - (c) For the purposes of this subregulation "value" shall mean –

-
- (i) for customs purposes, the value as defined in section seventy two of the Customs and Excise Act, 1964 (Act No. 91 of 1964); and
 - (ii) for the purposes of an authorised dealer, the full proceeds of the goods exported.”.

 - (a) Behoudens enige vrystelling wat deur die Tesourie verleen mag word, mag niemand goedere vanuit die Republiek uitvoer nie, tensy die betrokke inklaringsbrief-uitvoer ten opsigte van gemelde goedere behoorlik deur die afsender, of 'n persoon wat deur hom gemagtig is, ingevul en onderteken is.
 - (b) Die Tesourie kan gelas dat voormelde verklaring ingevul moet word ten opsigte van enige handels- of ander artikel, afgesien van die waarde daarvan.
 - (c) Vir die toepassing van hierdie subregulasie beteken "waarde" –

- (i) vir doeanedoeleindes, die waarde soos omskryf in artikel twee-en-sewentig van die Doeane en Aksynswet, 1964 (Wet No. 91 van 1964); en
- (ii) vir die doeleindes van 'n gemagtigde handelaar, die volle opbrengs van die goedere uitgevoer.”.

**PRIVATE SECURITY INDUSTRY REGULATION ACT, 2001
(ACT NO. 56 OF 2001): EXEMPTION IN TERMS OF
SECTIONS 1(2) AND 20(5) OF THE ACT**

By virtue of the power vested in the Minister of Police by sections 1(2) and 20(5) of the Private Security Industry Regulation Act, 2001 (Act No. 56 of 2001), I, Emanuel Nkosinathi Mthethwa, hereby determine that L-3 Communications Security and Detection Systems Co. Ltd and its employees, are exempted from the provisions of section 20(1)(a) of the Private Security Industry Regulation Act, 2001 (Act No. 56 of 2001), to register as security service providers, on condition that -

- L-3 Communications Security and Detection Systems Co. Ltd and its employees may only render a security service in terms of the agreement entered into with the South African Revenue Service for the provision and installation of air baggage scanners and cargo scanners;
- L-3 Communications Security and Detection Systems Co. Ltd and its employees may not provide any other security service to anyone else in the Republic; and
- this exemption will lapse after a period of five years from the date of publication of this notice.

ARTIKELS 1(2) EN 20(5) VAN DIE WET**
