**PRIVATE SECURITY INDUSTRY REGULATION ACT, 2001
(ACT NO. 56 OF 2001): EXEMPTION IN TERMS OF
SECTIONS 1(2) AND 20(5) OF THE ACT**

By virtue of the power vested in the Minister for Police by sections 1(2) and 20(5) of the Private Security Industry Regulation Act, 2001 (Act No. 56 of 2001), I, Emmanuel Nkosinathi Mthethwa, hereby determine that T Vermeulen (ID No. 600213 5094 084) and N M Sepuru (ID No. 710920 0905 084), are exempted from the provisions of sections 20(1) and 20(2) of the Private Security Industry Regulation Act, 2001 (Act No. 56 of 2001), for a period of five years from date hereof, on condition that -

- they may not directly or indirectly participate in or influence the decisions relating to the day-to-day security services provided by Jasco Trading (Pty) Ltd, trading as Multivid;
- they may not function as security service providers; and
- they remain in the employment of Jasco Trading (Pty) Ltd, trading as Multivid in the same position as indicated in their application.
