- (f) **New registrations:** Annual fees will become payable on the 1<sup>st</sup> of April of the year following the year of registration, provided that if a person is registered during the first three months of a year, the annual fees will become payable on the 1<sup>st</sup> of April of the same year.

**BOARD NOTICE 45 OF 2011****PRIVATE SECURITY INDUSTRY REGULATORY AUTHORITY**

In terms of the Private Security Industry Regulation Act, security businesses must pay annual amounts to the Authority. Failure to do so not only constitutes a criminal offence and contravention of the statutory Code of Conduct for Security Service Providers, but the Authority may also suspend the registration as security service provider. The effect of suspension is that the security service provider may not render a security service during the period of suspension but it is still bound by all the obligations of a registered security service provider in terms of the Act, which includes payment of annual fees. Consumers of security businesses may also not contract with a security business which is not lawfully registered. The following businesses' registrations were suspended by the Authority:
