**DECLARATION OF THE EARTHQUAKE THAT OCCURRED IN HAITI TO BE A  
DISASTER**

Under the powers vested in me by Section 26 of the Fund Raising Act, 1978 (Act No 107 of 1978), I hereby declare the earthquake that occurred on 12 January 2010 on the Caribbean Island of Haiti and caused severe damage and loss to be a disaster for the purposes of this Act.
