INDEPENDENT COMMUNICATIONS AUTHORITY OF SOUTH AFRICA (ICASA)

NOTICE IN FOR RE-CATEGORIZATION OF MEDIUM WAVE FREQUENCIES.

The Independent Communications Authority of South Africa ("The Authority") hereby gives notice in terms of the provisions of section 30(2) of the Electronic Communication Act, Act No. 36 of 2005 (" the EC Act"), of its intention to recategorized all underutilized "commercial" and "public" Medium Wave Frequencies for "Community Radio Services".

The Authority received requests from various concerned community broadcasters to consider re-categorizing the underutilized Medium Wave "commercial" and "public" Frequencies to "community", in areas that show high spectrum demand from the community broadcasters. The Medium Wave spectrum is currently underutilized, as may be seen from the current Broadcasting Frequency Plan. The last Medium Wave Frequency assignment was made in January 1999.

This shows that over the past eleven (11) years there has not been much interest for Medium Wave spectrum. However, some commercial broadcasters like *Life Music Radio* have recently shown great interest to the spectrum. Even with this interest the demand from the community broadcasters outweighs that of the commercial and public counterparts. It is also not foreseeable that the demand for Medium Wave spectrum from commercial and public broadcasters would significantly increase in the near future.

The detailed specifications of the proposed re-categorization are in schedule A below. The effective date of the re-categorization would be the date on which the Authority's decision on re-categorization would be published after consideration of all received public comments.

Interested parties are invited to lodge written representations in relation to the recategorization within 30 days from the date of publication. All written representations, responses and other correspondence in terms of herof must be directed to:
