NOTIFICATION OF AMENDMENT OF THE DETERMINATION MADE BY THE CIVIL AVIATION AUTHORITY TO IMPOSE A FUEL LEVY ON THE SALE OF AVIATION FUEL ("THE DETERMINATION")

The Civil Aviation Authority, in terms of section 2(7) of the South African Civil Aviation Authority Levies Act, 1998 (Act No. 41 of 1998), hereby amends the Determination contained in Government Notice No. R.1665 of 14 December 1998, as amended by Government Notices No. R.932 of 30 July 1999; No. R.1033 of 27 August 1999; No. R.1101 of 9 November 2005; No. R.473 of 25 April 2008 and No. R.163 of 26 February 2010, as follows:

AMENDMENT OF PARAGRAPH 2 OF THE DETERMINATION

1. Paragraph 2 of the Determination is hereby amended by the substitution in subparagraph (1) for the expression "4.00 cents" of the expression "12.2 cents".

DATE OF COMMENCEMENT

2. This Amendment shall come into operation on 1st June 2011.
