LEGAL NOTICE: ELECTION OF THE ALLIED HEALTH PROFESSIONS COUNCIL OF SOUTH AFRICA – SECOND CALL FOR NOMINATIONS OF CANDIDATES TO BE APPOINTED BY THE MINISTER OF HEALTH AS MEMBERS OF THE ALLIED HEALTH PROFESSIONS COUNCIL AND AS MEMBERS OF THE PROFESSIONAL BOARDS

In terms of the provisions of Regulation 4 (GNR127, 12/02/2001) of the Allied Health Professions Act, 63 of 1982, as amended ("the Act"), notice is hereby given to call for nominations of 5 persons appointed by the Minister of Health to serve on the Allied Health Professions Council of South Africa. In terms of Section 5(1)(b)(ii) and (iii) of the Act the Minister of Health shall appoint to the Council:

- one person who shall be appointed on account of his/her knowledge of the law; and
- four persons as community representatives, who shall be appointed on account of expertise in the fields of health, education and welfare.

Nominations of persons received in terms of Section 5(1)(b)(ii) and (iii) of the Act shall be in writing, signed by the person making the nomination and shall provide that the nominee declares that he/she is not registered in terms of the Allied Health Professions Act, is a South African citizen residing within the Republic and is not an unrehabilitated insolvent. The nomination shall be signed by the nominee indicating his/her acceptance of the nomination and willingness to serve on Council should he/she be appointed. All nominations shall include a **detailed** curriculum vitae of the nominee. Nomination forms, duly completed and signed, must be returned to The Director: Public Entity and Governance by post at the address given above, or at fax number (012) 395 8763. Persons who have already submitted nominations as per the first call in the above regard need not resubmit nominations; these will form part of the consideration process.
