NOTICE 426 OF 2011**ELECTRONIC COMMUNICATIONS ACT, 2005 (ACT NO. 36 OF 2005)****APPLICATION FOR A TRANSFER OF AN INDIVIDUAL COMMERCIAL SOUND BROADCASTING SERVICE LICENCE FROM EAST COAST RADIO (PTY) LTD TO KAGISO BROADCASTING (PTY) LTD**

1. The Independent Communications Authority of South Africa ("the Authority") hereby gives notice that it has received an application from East Coast Radio (Pty) Ltd ("ECR"), for a transfer of its Individual Commercial Sound Broadcasting Service Licence lodged in terms of regulation 11 of the Processes and Procedures Regulations for Individual Licences and Special Temporary Authorisations of 2010 read with sections 13(1) and (2) of the Electronic Communications Act, No 36 of 2005.
2. The transfer application seeks the approval from the Authority to transfer the Individual Commercial Sound Broadcasting Service Licence from ECR to Kagiso Broadcasting (Pty) Ltd ("KBL").
3. The application, relevant schedule and any representations received pursuant thereto would be made available and be open for inspection by interested parties in the Authority's library during the Authority's normal office hours.
4. Interested parties are invited to lodge written representations in relation to the application within twenty one (21) days of the date of publication of this notice.

ECR shall be entitled to respond in writing to written representations made by interested persons on the transfer application, and such written response must be lodged with the Authority within forty two (42) days of the date of publication of this notice in the *Government Gazette*. ECR must, at the time of lodging such written response, furnish proof to the Authority's satisfaction that it has delivered a copy of such response by hand, or has sent a copy of such response by registered mail or by facsimile to the relevant person having made such written representations.
