Notice and Order of Forfeiture

Notice of Forfeiture to the State of money and/or goods in terms of the provisions of Regulation 22B of the Regulations ("the Exchange Control Regulations") made under Section 9 of the Currency and Exchanges Act, 1933 (Act No. 9 of 1933), as amended, as promulgated by Government Notice No. R.1111 of 1961-12-01 in respect of the money and/or goods of:

3. The date upon which the money and/or goods specified in 2 above is/are hereby forfeited to the State is the date upon which this Notice of Forfeiture is published in this Gazette.
4. The money and/or goods specified in 2 above will be disposed of by depositing such money, or the proceeds thereof, into the National Revenue Fund and in the case of goods, the realisation of such goods in such manner as the Treasury may deem fit, whereafter the proceeds thereof will be deposited into the National Revenue Fund.
5. This Notice also constitutes a written order, as contemplated in Regulation 22B of the Exchange Control Regulations, in terms of which the money and/or goods specified in 2 above is/are hereby forfeited to the State.
