INDIVIDUAL ELECTRONIC COMMUNICATIONS NETWORK SERVICES AND ELECTRONIC COMMUNICATIONS SERVICES SHAREHOLDING STRUCTURE

1. The Independent Communications Authority of South Africa ("the Authority") hereby gives notice in terms of section 4(3)(b) of the ICASA Act No. 13 of 2000, as amended read with regulation 3(1) and 3(4) of the Regulations in respect of Limitation of Ownership and Control of Telecommunication Services, of its intention to conduct an audit of Individual Electronic Communications Network Services and Electronic Communications Services.
2. Licensees are requested to advise the Authority in terms of their compliance with the HDI shareholding structures. The following information in respect of shareholding is required to be submitted:
 - 4.1 current shareholding structure; and
 - 4.2 percentages held by HDI or groupings (if any).
 - 4.3 the percentage held by youth, women and people with disabilities, if any.
3. Licensees are requested to provide proof of such in the form of CIPRO documentation and/or a sworn affidavit.
4. The information is requested from the licensees to allow the Authority to update its database of existing and operational licensees, which in turn would enable the Authority to plan its monitoring activities going forward.

5. Submissions are due by no later than 16h00 on: **30 August 2011.**
