Definition

1. In this Schedule any word of expression to which a meaning has been assigned in the Notice shall have that meaning, and "the Notice" means Government Notice No. R. 955 of 9 October 2009.

Amendment of clause 5 of the Notice

2. Clause 5 of the Notice is hereby amended by –

The deletion of paragraph (4) and the inclusion of paragraphs (4) and (5) below:-

- (4) The levy administrator is entrusted in terms of section 14 of the Act with the implementation, administration, collection of statutory levies, and/or enforcement of the statutory measure established in this regulation; and
- (5) The levy administrator is herewith authorised and empowered to delegate its powers conferred herein to, and/or appoint any independent third party to assist with the implementation, administration, collection of statutory levies, and/or enforcement of the statutory measure.

Commencement and period of validity

3. These amendments will be effective from 1 January 2012 and will lapse on 8 October 2013.
