CALL FOR COMMENTS ON DEREGISTRATION OF LEARNERSHIPS IN TERMS OF THE LEARNERSHIP REGULATIONS, 2007: REGULATION 4

In terms of the Learnerships Regulations, 2007 Regulation 4 sub regulation (1)(a) (2)(a)(b), I, Gwebinkundla Qonde, Director General of Higher Education and Training, hereby publish for public comments the draft notice for deregistration of learnerships, attached hereto as Schedule 1.

The various Sector Education and Training Authorities (SETAs) have requested the Director-General in writing to deregister Learnerships in terms of Regulation 4 sub regulation (2). The reasons for deregistration of specified Learnerships are as follows:

- Learnerships that are active but have no learners enrolled in them.
- Learnerships that are not linked to a South African Qualifications Authority (SAQA) qualification.
- Learnerships that are no longer relevant to the sector.
- Learnerships that have expired.
- Learnerships that are linked to a SAQA qualification that has expired.
- Learnerships that are outside the scope of operation of the SETA.

Regulation 4 sub regulation (3) further states that the deregistration of a learnership does not affect -

- a. The rights and obligations of the parties to any learnership agreement in respect of that learnership in force at the time of deregistration;
- b. The validity of any learnership completed by a learner or any qualification associated with the learnership achieved by a learner
 - i. before deregistration of the learnership; or
 - ii. in respect of any period of learnership that is commenced before the deregistration of the learnership and which the learner has duly completed.

After consulting with the National Skills Authority (NSA), the list of Learnerships is hereby published in the schedule hereto for public comment.

Interested parties are hereby given the opportunity to submit written comments on the deregistration of learnerships within 30 days after the publication date of this Notice by-
