DEPARTMENT OF ENERGY**No. R. 1019****6 December 2011****PETROLEUM PRODUCTS ACT, 1977 (ACT No. 120 OF 1977)****REGULATIONS IN RESPECT OF THE SINGLE MAXIMUM
NATIONAL RETAIL PRICE FOR ILLUMINATING PARAFFIN**

1. I, Ms Dipuo Peters, Minister of Energy, under section 2(1)(c) of the Petroleum Products Act, 1977 (Act No. 120 of 1977), determine that a maximum retail price for Illuminating Paraffin (excluding the price of any form of packaging) will become effective on the first Wednesday of each month.
2. The maximum retail price for illuminating paraffin, excluding the price of any form of packaging for the period 07 December 2011 to 03 January 2011 will be 1064.0 c/l.
3. **Commencement**
These regulations shall come into operation at **00:01 on 07 December 2011.**
