- Acting as a formal channel of communication with government on issues related to the marine finfish aquaculture sector;

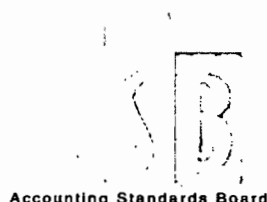
