WET OP BURGERLIKE LUGVAART, 2009 (WET NO 13 VAN 2009)

Die Minister van Vervoer het kragtens artikel 155(1)(z)(ii) geles met artikel 74(1)(b) van die Wet op Burgerlike Lugvaart 2009 (Wet No. 13 van 2009), die Burgerlike Lugvaartowerheid Passasiersveiligheidsheffingregulasies, 2010, soos in die Skedule hieronder vervat, gewysig.

SKEDULE**WYSIGING VAN DIE BURGERLIKE LUGVAARTOWERHEID
PASSASIERSEILIGHEIDSCHEFFINGREGULASIES, 2010**

1. Regulasie 2 van die Burgerlike Lugvaartowerheid Passasiersveiligheidsheffingregulasies, 2010, word hiermee gewysig deur die vervanging van subregulasie (1) deur die volgende subregulasie:

“(1) ‘n Burgerlike Lugvaartowerheid Passasiersveiligheidsheffing wat R16.00 bedra, is betaalbaar deur passasiers wat op ‘n vliegtuig vanaf ‘n vliegveld binne die Republiek op ‘n geskeduleerde openbare lugvervoervlug of gedeelte van ‘n vlug na ‘n bestemming binne of buite die gebied van die Republiek van Suid-Afrika ,vertrek.”.
