PETROLEUM PRODUCTS ACT, 1977 (ACT No. 120 OF 1977)**REGULATIONS IN RESPECT OF THE SINGLE MAXIMUM
NATIONAL RETAIL PRICE FOR ILLUMINATING PARAFFIN**

1. I, Ms Dipuo Peters, Minister of Energy, under section 2(1)(c) of the Petroleum Products Act, 1977 (Act No. 120 of 1977), determine that a maximum retail price for Illuminating Paraffin (excluding the price of any form of packaging) will become effective on the first Wednesday of each month.
2. The maximum retail price for illuminating paraffin, excluding the price of any form of packaging for the period 01 February 2012 to 06 March 2012 will be 1027 c/l.
3. **Commencement**
These regulations shall come into operation at **00:01 on 01 February 2012.**
