



“Fishing Industry” means the Industry in which employers and employees are associated for the purposes of legally exploiting in respect of the Marine Living Resources Act, No. 18 of 1998, any form of marine living resource by searching, catching, taking or harvesting, farming, growing, the procuring and processing of fish, for financial gain, by Deep-Sea Bottom Trawling, In-Shore Bottom Trawling and Mid Water Trawling.

“Deep-Sea Bottom Trawling” means the fishing operations at sea in which the employers and their employees are associated for the purpose of Deep-Sea Bottom Trawling by way of a net for fin fish species outside a five nautical mile perimeter west of twenty degrees east longitude and outside the hundred-and ten meters isobaths east of twenty degree east longitude.

“In-Shore Bottom Trawling” means the fishing operations at sea in which the employers and their employees are associated for the purpose of Bottom Trawling within the hundred-and-ten meters isobaths.

“Mid-Water Trawling” means fishing for Horse Mackerel with any net which can be dragged by a fishing vessel along any depth between the bed and the surface of the sea without continuously touching the bottom.

“Processing of Fish” for the purposes of this definition means the activities undertaken on any vehicle or vessel at sea, where any substance or article is produced from any form of marine living resources by any method, including but not limited to the work of cutting up, dismembering, separating parts of, cleaning and sorting, lining and preserving thereof or where any form of marine living resources are packed, dried, gutted, salted, iced, chilled, frozen or otherwise processed for sale.

 - (ii) “the Rules” means the Rules for the Property Valuers Profession, 2008.

Amendment of Annexure C.1 to Rules

2. Annexure C.1 to the Rules is hereby amended-

- (a) By the substitution for paragraph (a) of item 2 of the following paragraph:

“(a) has attended a practice orientated workschool [approved] administered by the council or its nominee, and where appropriate and deemed necessary by the council, passed the examination conducted at the end thereof;” and

- (b) By the insertion after item 5 of the following item:

“Additional requirements

5A. Without derogating from the provisions of this Annexure, the council may, in order to be satisfied that a person applying for registration as a professional, and with due regard to his or her application as a whole, require that that person-

- (a) gain further practical experience of work in property valuation in general or in respect of any purpose of property valuation or type of property valuation referred to in paragraph (a) or (b) of item 3, respectively, including the time during which he or she must gain such experience;
- (b) perform a minimum of one property valuation assignment, consisting of the performance of any type of property referred to in paragraph (b) of item 3, including a fully motivated written valuation report or reports, thereof, determined by the council;
- (c) submit at least one certified copy of a property valuation report done by him or her, as identified by the council;
- (d) appear before the council for a personal interview regarding his or her experience in property valuation work; or
- (e) submit any information or document relevant to his or her application, as identified by the council”.

Amendment of Annexure C.2 to Rules

3. Annexure C.2 to the Rules is hereby amended-
- (a) by the substitution for paragraph (b) of item 2 of the following paragraph:
“(b) written proof of completion of [the] a practice orientated workschool administered by the council or its nominee;” and
 - (b) by the insertion after item 6 of the following item:

“Additional requirements

6A. Without derogating from the provisions of this Annexure, the council may, in order to be satisfied that a person applying for registration as a single residential property assessor, and with due regard to his or her application as a whole, require that that person-

- (a) gain further practical experience of work in the valuation of single residential properties, including the time during which he or she must gain such experience;
- (b) perform at least one property valuation assignment (other than the one contemplated in paragraph (c) of item 2) of a single residential property determined by the council, including a fully motivated written valuation report or reports thereof;
- (c) submit at least one certified copy of a property valuation report (other than the one contemplated in paragraph (c) of item 2) done by him or her;
- (d) appear before the council for a personal interview regarding his or her experience in property valuation work; or
- (e) submit any information or document relevant to his or her application, as identified by the council.”.

Short title and commencement

4. These rules shall be called the First Amendment to the Rules for the Property Valuers Profession and shall commence on 1 April 2012.
