## NOTICE 297 OF 2012

### DEPARTMENT OF TRANSPORT

#### NATIONAL ROAD TRAFFIC ACT, 1996 (ACT NO. 93 OF 1996)

#### ABNORMAL LOADS EXEMPTION PERMIT FEES

The Department of Transport hereby publishes the abnormal loads exemption permit fees for the financial year 2012/2013 .

### EXEMPTION PERMIT FEES FOR 2012/2013

It is one of the basic functions of the Abnormal Loads Technical Committee to recommend the fees relating to exemption permits. For obvious considerations of credibility and efficiency fees should be uniformly calculated and applied by all provinces.

The fees are set to optimise the income derived by the provincial governments based on actual scientifically determined costs and indexed to the Producer Price Index (PPI)

The mass factor, M, is based on a value of R0.18 / km and the congestion factor, K, on a value of 0,01615 based on the June 1995 Production Price Index (namely 100,00) and adjusted annually. The factors for 2012/ 2013 will be based on the latest available figures for June 2005 and then rounded off.
