**DECLARATION OF EXSITING PROVINCIAL ROAD – PROVINCIAL TRUNK ROAD 45
SECTIONS 1 AND 4 AS NATIONAL ROAD R72 SECTIONS 1 AND 4 – DISTRICTS OF
ALEXANDRIA, PEDDIE, MDANTSANE AND EAST LONDON (SECTION 1 FROM THE
N10 TO ALEXANDRIA AND SECTION 4 FROM PEDDIE TURN-OFF TO EAST LONDON)**

By virtue of Section 40 (1)(a) of The South African National Roads Agency Limited and National Roads Act, 1998 (Act No. 7 of 1998), I hereby declare:

- i) Provincial Trunk Road 45 Section 1 also known as Route R72, all as declared by Administrator Notices Nos. 157 of 1951, 141 of 1961 and 38 of 1994 and all other Notices which might be relevant to this section of road, commencing from its junction with the National Road N10 on the Farm Nanaga Hoogte 299 as declared by Declaration no. 982 of 2008, from where it proceeds in a general easterly direction along the existing Provincial Trunk Road 45 Section 1 up to the junction of Provincial District Road 01941 at Alexandria, where it terminates and
- ii) Provincial Trunk Road 45 Section 4 also known as Route R72, all as declared by Administrator Notices Nos. 157 of 1951, 141 of 1961 and 38 of 1994 and all other Notices which might be relevant to this section of road, commencing from its junction with Main Road 0523 also known as Route R345 on the Farm No. 107, from where it proceeds in a general north easterly direction on the existing provincial Trunk Road 45 Section 4 up to the East London Airport access junction where it terminates, to be a National Road.



- ii) Provinsiale Grootpad 45 Seksie 4 ook bekend as Roete R72, soos verklaar deur Administrateurskennisgewings no's 157 van 1951, 141 van 1961 en 38 van 1994 asook alle ander Kennisgewings wat betrekking op hierdie gedeelte van pad mag hê, beginnende vanaf die aansluiting met Hoofpad 0523 ook bekend as Roete R345 op die Plaas no. 107, daarvandaan met die bestaande Provinsiale Grootpad 45 Seksie 4 in 'n algemene noord oostelike rigting tot by die aansluiting van die Oos London Lughawe toegangspad, waar dit eindig, tot 'n Nasionale Pad.
