
### BOARD NOTICE 83 OF 2012

#### THE SOUTH AFRICAN PHARMACY COUNCIL

#### FEES PAYABLE TO THE COUNCIL UNDER THE PHARMACY ACT 53 OF 1974

In terms of section 4(zG) of the Pharmacy Act 53 of 1974, Council may determine the fees payable to Council, without publication thereof in regulations. In practice, this would mean that any new fees or amendments to existing fees will be determined by Council. As in the past, all efforts will be made to curtail costs and keep any increases in fees to the minimum. The additional fees and amended fees for 2012, read together with Board Notice 170 of 2011, published on 28 October 2011, are published below for general information:
