The application is lodged in terms of Regulation 5 (c) schedule 1 of the Regulations Regarding Standard Terms and Conditions for Individual Licences, as published in Gazette Number 33294 on 14 June 2010
2. On 15 March 2011, the Authority issued WOW tv with a an individual subscription television broadcasting service licence.
