**DETERMINATION OF SALARIES OF DEPUTY DIRECTORS OF PUBLIC

1. The objective of this determination is to introduce the determination of salaries of Deputy Directors of Public Prosecutions, Chief Prosecutors and Chief Special Investigators under the National Prosecuting Authority act, 1998 as well as further amendments:

1.1 A cost-of-living adjustment of 4.5% effective from 1 January 2012 and an additional 0.5% effective from 1 April 2012, delinked from performance.

- 1.2 1 April as annual cost of living adjustment date, with the next adjustment effective from 1 April 2013.
  - 1.3 A basic salary component of 70% in the SMS remuneration package, effective from 1 April 2012.
  - 1.4 Once-off (irrevocable) choice between pre-1 April 2012, 63% basic salary or the revised 70% basic salary for SMS members/employees who are remunerated in terms of the SMS remuneration dispensation on 31 March 2012.
