

Attached, are the new tariffs for ease of reference.

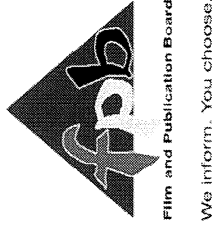
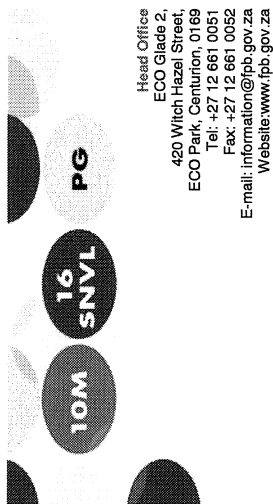
