# MAGISTRATES' COURTS ACT, 1944: AMENDMENTS TO THE ESTABLISHMENT OF COURTS FOR REGIONAL DIVISIONS FOR THE ADJUDICATION OF CERTAIN CIVIL DISPUTES

- I, Jeffrey Thamsanqa Radebe, Minister of Justice and Constitutional Development, acting under section 2(1)(d), 2 (1) (g)(ii), 2(1)(iA) of the Magistrates' Courts Act, 1944 (Act No. 32 of 1944), hereby, with effect from 6 August 2012, amend Government Notice No. 670 published in Government Gazette 33418 of 29 July 2010 by -
- (a) deleting, in Schedule 1 to the Notice, the magisterial district or area of Alberton referred to in Column D corresponding to the appointed area for holding of a court for adjudication of civil disputes of Germiston referred to in Column C in relation to the Regional Division Gauteng indicted under Column A of the said Schedule; and
- (b) adding, in Schedule 1 to the Notice, under Column C immediately under Kempton Park, Palm Ridge as a place appointed for the holding of a court for the adjudication of civil disputes; and inserting under Column D corresponding to Palm Ridge, Alberton as a magisterial district or area in respect of which the appointed place for holding a court for the adjudication of civil disputes of Palm Ridge shall have jurisdiction in relation to the Regional Division Gauteng indicted under Column A of the said Schedule.
